WHEREAS, the recognition was granted to the institution namely S.V.S College of Education, Martin Luther School Campus, 208, 15th Main, Nagendra Block, Banashankari 3rd Stage, Girinagar, Bangalore, Karnataka-560050 run by Sri Venugopalaswamy Educational Trust, Bangalore, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2008-2009/4408 dt. 30.08.2008 for conducting (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2008-2009.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014 a provisional revised recognition order dt. 18.05.2015 was issued to the institution namely S.V.S. College of Education for conducting B.Ed. course of two years' duration with an annual intake of 50 students (1 Unit). In this regard, it is pertinent to mention that the Affidavit (required to be submitted by the TEIs for issuance of RPRO) was submitted by the institution in the name of Anugraha B.Ed. College.

3. AND WHEREAS, the institution submitted the compliance of RPRO vide its letter dt. 31.07.2015 with the new name i.e., Anugraha B.Ed. College.

4. AND WHEREAS, the matter of change of name of college was considered by the SRC in its 317^{th} meeting held on $28^{\text{th}} - 30^{\text{th}}$ July 2016. The decision is reproduced below: -

- (i) Lease hold right is there. They can continue to operate there until the lease period runs out. Remove the shifting condition.
- (ii) No shifting inspection is required.
- (iii) They want only 1 Unit therefore, inspection for the 2nd unit is also not required.
- (iv) Obtain original FDRs and the latest Faculty List.
- (v) Issue Notice accordingly. We will have to issue a revised Formal Recognition for B.Ed. (1 Unit) with only 50 intakes.
- (vi) As regards change of name, let them follow the prescribed procedure and submit documents accordingly.

5. **AND WHEREAS**, the institution submitted the compliance of above notice (issued on 09.11.2016) vide its letter dt. 28.11.2016 specifically stating that the procedure to change the name according to NCTE norms will be followed.

6. AND WHEREAS, the matter was again considered by the SRC in its 348^{th} meeting held on $5^{\text{th}} - 6^{\text{th}}$ December 2017. The decision is reproduced below: -

(i) Their reply to the SCN is not accompanied by FDRs and Faculty List in the prescribed format. Obtain.

- (ii) The 'change of name' aspect has not received attention. This will have consequential implications for all documents, esp. the Lease Deed. Ask them to explain the current status.
- (iii) Re-examine and resubmit on 15/12.
- (iv) We can send a composite SCN thereafter.

7. AND WHEREAS, a show cause notice dt. 12.12.2017 was issued to the institution and the institution submitted its reply vide letter dt. 14.12.2017 requested for extension of time. The institution submitted its reply vide letter dt. 23.01.2018 inter-alia requesting for change of name of institution. The matter was considered by the SRC in its 383^{rd} meeting held on $7^{th} - 9^{th}$ January 2020 and decided to issue Final Show Cause Notice with refusal of request for change of name of College. The decision is reproduced below: -

(i) The committee decided that the change of name of the institution is not permitted.

Further, the committee also decided to issue Final Show Cause Notice to the institution on the following grounds: -

- *(i) The institution is required to submit the NEC duly approved by the competent authority.*
- (ii) The institution is required to submit the BCC duly approved by the competent authority.
- (iii) The institution is required to submit the certified copy of land documents of registered land.
- (iv) The institution is required to submit original blue-prints of building plan duly approved by the competent authority.
- (v) The institution is required to submit the LUC duly approved by the competent authority.
- (vi) The institution is required to submit latest staff list approved by the affiliating body as per prescribed format.

8. AND WHEREAS, the Final Show Cause Notice on the basis of above decision was issued on 06.01.2020. The reply submitted by the institution on 23.06.2020 was considered by the SRC in its 401^{st} meeting held on $11^{th} - 12^{th}$ August 2021 and decided to withdraw the recognition of the institution on the following grounds: -

- (i) The initial recognition was granted to the institution namely S.V.S. College of Education under the management of Trust namely Sri Venugopal Swamy Educational Trust whereas now both have been changed as Anugraha B.Ed. College and Backward Class Education Trust. This is not permissible under the provisions stipulated under NCTE Regulations, 2014.
- (ii) The land documents now submitted pertains to Survey number 74 whereas the initial recognition was granted on the land at 206. Change of location without prior approval is established and not acceptable in light of provisions stipulated under clause 8(9) of NCTE Regulations, 2014.
- (iii) The institution is reported to be functioning at Survey No. 74 and the land acquired through a Lease Deed dt. 19.07.2009 executed between private parties for a period of 30 years. The Lease Deed executed between private

parties is not acceptable after notification of NCTE Regulations, 2007 and 2014.

- (iv) The institution submitted a copy of letter dt. 23.03.2020 issued by the Registrar, Bengaluru Central University inter-alia approving only 7 faculty. The faculty strength is not enough for running even one Unit of B.Ed. course as stipulated under para 5.1 of Appendix 4 of NCTE Regulations, 2014.
- (v) Further, the faculty has been approved by the Registrar of the Bengaluru Central University with the condition that "All appointments are approved with a condition to clear NET / SLET / Ph.D. in Education within two years from the date of approval. Conditional approval is not acceptable under NCTE Regulations.
- (vi) The proforma of faculty is without mention of the date of joining of faculty.
- (vii) The building plan of the institution has been submitted only for the 5th floor. Further, the building plan is not approved by the competent authority.
- (viii) The institution did not submit Land Use Certificate, Non-Encumbrance Certificate and BCC in prescribed format.
- (ix) The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

9. AND WHEREAS, the SRC in its 401st Meeting held on 11th & 12th August, 2021 considered the matter and decided to issue withdraw the recognition. Accordingly, as per decision of SRC a withdrawal order vide no. F.SRO/NCTE/APS03516/B.Ed./{KA} /2021/128366 on 24.08.2021 was issued to the institution.

10. AND WHEREAS, the institution has submitted a written representation vide letter dt. 03.09.2021.

11. AND WHEREAS, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"In response to the decision taken by the SRC in its 401^{st} meeting held on $11^{th} - 12^{th}$ August 2021.

The decision may be read as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 23.06.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The initial recognition was granted to the institution namely S.V.S. College of Education under the management of Trust namely Sri Venugopal Swamy Educational Trust.
- 2. The Committee in light of letter No. ED476UBV2007 dt. 07.12.2007 issued by the Govt. of Karnataka and letter No. ACA-3/A3/SVSCE:2007-08 dt. 20.09.2007 issued by the Vice Chancellor, Bangalore University decided that the request of the institution regarding change of name of institution from S.V.S. College of Education to Anugraha

B.Ed. College is accepted and rectified. The Committee also decided not to allow change in the name of the trust. Necessary change on the website of the SRC, NCTE be made.

3. The Committee further decided to issue the Final Show Cause Notice for submission of compliance of adherence of conditions of NCTE Regulations, 2014 be issued to the institution under its new name. The withdrawal order issued as per the decision of SRC taken in the 401st meeting be treated as cancelled."

Additionally the institution is required to submit the following documents:-

- The institution is required to submit certified copy of land documents issued by concerned (i) Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents
- The institution is required to submit an attested/notarised copy of Land Use Certificate (ii) issued by the Competent Authority
- The institution has not submitted a copy of Non-Encumbrance Certificate issued by the (iii) Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
- The institution is required to submit an attested/notarised copy of the approved Building (iv) Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- (v) An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- The Institution is required to submit an attested/notarised copy of Building Completion (vi)Certificate issued by the competent authority.
- The institution is required to submit Staff list duly approved by the Registrar of the (vii) affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- The institution has not submitted original FDRs to the SRC, NCTE The institution is (viii) required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs.
- Details of Teacher Education programme (s) being run by the Institution in the same (ix) campus

(xii) Domain name of the website being run by the institution.

The institution shall be required to submit an Affidavit clearly stating status about land (xiii) & building and Management (Society/Trust) at the time of recognition and its present status giving following details

- (i) Details of land & building available at the time of recognition with the Institution
- (ii) Details of land & building now available with the Institution
- (iii) Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

"The institution shall note that in case, where the institution is conducting more than one Teacher Education Programme, detail of (i) total build up area available in a composite manner showing the same in duly earmarked building plan for each of the teacher education programme (iii) latest faculty list duly approved by the affiliating body (iii) FDRs respectively provided for additional programmes is required to be submitted indicating the intake for each programme."

12. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

Your reply, complete in all respects must reach this office on or before 21 days of the issue of this Final Show Cause Notice.
