### **ORDER**

WHEREAS, recognition was granted to Jnana Bharathi College of Education, N.H. 206. KadurChikmagalur - 577548, Karnataka run by Jnana Bharathi Home for Education, Karnataka vide order dated 01.12.2004 for running B.Ed. course of one year duration with an annual intake of 100.

- AND WHEREAS, a Show Cause Notice No. APSO2162/B.Ed./KA/2011-12/29133 dated 15.6.2011 was issued to the institution (shifting case). The institution has not submitted any reply as per the records available in file
- 3. AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure), Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.
- AND WHEREAS, the institution by a notarized affidavit dated 05.02.2015 consented to come under the new Regulations.
- AND WHEREAS, in light of the above and in accordance with the NCTE Regulations. 2014, the SRC, NCTE issued the revised recognition order dated 31.05.2015 to Jnana Bharathi College of Education, N.H. 206, KadurChikmagalur - 577548, Karnataka for conducting B.Ed. course of two years duration with an annual of 100 students (two basic units) of 50 students each from the academic session 2015-16 subject to fulfillment of the conditions mentioned therein.
- AND WHEREAS, a corrigendum No. F. SRO/NCTE/APSO2162/B.Ed./KA/2015-16/69053 dated 01.07.2015 was issued to the institution for conducting B.Ed. programme of two years duration with an annual of 50 students (one basic unit) from the academic session 2015-16 subject to fulfillment of the conditions mentioned therein.
- 7. AND WHEREAS, the matter regarding complaint by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

8. AND WHEREAS, a Show Cause Notice was issued to the institution on 12.2.2019. The institution vide letter dated 05.03.2019 submitted a written representation. The SRC in its 376<sup>th</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> June, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Jnanabharathi College of Education, N.H. 206, KadurChikmagalur – 577548, Karnatakafor conducting B.Ed. coursew.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the following grounds: -

- 1. The institution in-spite of two SCNs is reluctant to furnish the required information for the continuation of recognition in view of non-availability of the documents, the Committee decided to withdraw the recognition.
- 9. AND WHEREAS, as per the decision of SRC, a Withdrawal order no. F.SRO/NCTE/APSO2162/B.Ed/KA/2019/106322-6328 dated 01.07.2019 was issued to the institution.
- 10. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.91-29<sup>th</sup>/30<sup>th</sup>/ Mtg./2019-/Appeal/83416 dated 25.10.2019 and the Council remands back the case. The operative part of the Appeal order is as under:-

"AND WHEREAS the Committee, noting that the appellant, with their appeal, enclosed copies of the documents found wanting, as per the Show Cause Notice dt. 12.02.2019, concluded that the matter deserved to be remanded to the SRC with a direction to consider these documents given in appeal, to be submitted by the appellant to them, and take further action as pe the NCTE Regulations, 2014. The appellant is directed to forward to the SRC all the documents, including copies of letters written to SRC about the FDRs submitted in appeal, with originals thereof, wherever necessary, within 15 days of receirs of order on the appeal.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents or record and oral arguments advanced during the hearing, the Committee concluded that the case deserve to be remanded to the SRC with a direction to consider the documents given in appeal, to be submitted by the appellant to them, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the SRC all the documents, including copies of letters written to SRC about the FDRs submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal. NOW THEREFORE, the Council hereby remands back the case of Jananbharathi College of Education, Opp. Railway Station, K.M. Road, Kadur, Chickmagalur, Karnataka to the SRC, NCTE, for necessary action as indicated above.

11. AND WHEREAS, the institution vide letter dated 26.10.2019 submitted a written representation along with the documents. The SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> October – 01<sup>st</sup> November, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Jnana Bharathi College of Education, N.H. 206, Kadur Chikmagalur – 577548, Karnataka for B.Ed programme for 1 unit of 50 students.

- 12. NOW THEREFORE, this order is issued permitting the institution i.e. Jnana Bharathi College of Education, Ass No. 334/320 & 335/321, K.M. Road, Kadur Town, Chikmagalur District 577548, Karnataka run by Jnana Bharathi Home for Education Trust, K.M. Road, Kadur, Chikmagalur, Karnataka for continuation of recognition for B.Ed course of two year duration with an intake of 50 students (one unit) subject to fulfillment of the following conditions:
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 14. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification. Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities:
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
- i. The affidavit with enclosure submitted along with application.
- i. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 17.
- The institution shall fill the information on GIS Portal on the NCTE Website. 18.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
