WHEREAS, St. Xavier College of Education, No. 45, Karuppur, Marudhanallur P.O., Thippirajapuram, Kumbakonam Taluk, Tanjore District, Tamilnadu-612402 was granted recognition for offering B.Ed course vide order no. F.TN/SEC/SRO/NCTE/2005-2006/833 dt. 13.07.2005 of one year duration with an intake of 100 students.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 22.01.2015 (B.Ed.), the provisional revised recognition order was issued to the institution on 12.05.2015 for conducting **B.Ed.** course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, Show Cause Notice was issued to the institution on 15.08.19. the institution submitted a reply on 09.10.2019 for both B.Ed & M.Ed courses in compliance of Show Cause Notice.

AND WHEREAS, the matter was finally considered by the SRC in its 381st meeting held from 31st October – 1st November, 2019 decided as under:-

On the perusal of the original documents and records made available in the file. The Committee decided that the following:-

- (i) A continuation order be issued to St. Xavier College of Education, No. 45, Karuppur, Marudhanallur P.O., Thippirajapuram, Kumbakonam Taluk, Tanjore District, Tamilnadu-612402 for B.Ed programme for 2 units (50 students each unit).
- (ii) Also a continuation order be issued to St. Xavier College of Education, No. 45, Karuppur, Marudhanallur P.O., Thippirajapuram, Kumbakonam Taluk, Tanjore District, Tamilnadu-612402 for M.Ed programme for 1 unit (50 students).

NOW THEREFORE, this order is issued permitting the institution St. Xavier College of Education, No. 45, Karuppur, Marudhanallur P.O., Thippirajapuram, Kumbakonam Taluk, Tanjore District, Tamilnadu-612402 run by Integrated Multi Service Trust, 45-Karuppur, Marudhanallur Post, Thippirajapuram Village, Kumbakonam Taluk, Tanjore District, Tamilnadu-612402 for continuation of conducting B.Ed course of two years duration with an intake of 100 students (Two basic units of 50 students each unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
