ORDER**

**WHEREAS**, Dr. David Raja & Dr. Chandraleka College of Education, Vengalapuram Village & Post, Tirupattur-635653, Vellore District, Tamilnadu was granted recognition for offering B.Ed course vide order no. F.TN/SEC/SRO/NCTE/2005-2006/5271 dt.31.01.2006 of one year duration with an intake of 100 students.

**AND WHEREAS**, on 29.01.2015, the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised provisional recognition order was issued to the institution on 30.04.2015 for offering B.Ed course of two years duration with an intake of 100 students ( 2 units of 50 students each) subject to fulfillment of certain conditions mentioned therein.

**AND WHEREAS**, the institution submitted compliance against RPRO issued in respect of B.Ed. course vide letter dt. 28.10.2015.

**AND WHEREAS**, a general decision was taken by the SRC in its 314<sup>th</sup> meeting to cause inspection of such institutions.

Accordingly, letter dt.14.06.2016 was issued to the institution for causing inspection but the inspection was not carried out.

**AND WHEREAS**, on the basis of decision taken by the SRC in its 380<sup>th</sup> meeting held on 18<sup>th</sup> – 19<sup>th</sup> September, 2019 a Final Show Cause Notice was issued to the institution dt.26.09.2019 with the direction to submit compliance of RPRO. The institution submitted its reply along with documents dt. 26.08.2019.

**AND WHEREAS**, the matter was finally considered by the SRC in its 381<sup>st</sup> meeting held from 31<sup>st</sup> October – 1<sup>st</sup> November, 2019 decided as under:-

"On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Dr. David Raja & Dr. Chandraleka College of Education, Vengalapuram Village & Post, Tirupattur-635653, Vellore District, Tamilnadu for B.Ed programme for 2 units (50 students each unit).

**NOW THEREFORE**, this order is issued permitting the institution On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Dr. David Raja & Dr. Chandraleka College of Education, Vengalapuram Village & Post, Tirupattur-635653, Vellore District, Tamilnadu for B.Ed programme for 2 units (50 students each unit) run by Dr. David Raja & Dr. Chandraleka Charitable Trust, Vengalapuram Village & Post Tirupattur Taluk, Vlr, District 635653, Tamilnadu for continuation of conducting B.Ed course of two years duration with an intake of 100 students (Two basic units of 50 students each unit) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 15 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a. Sanctioned programme(s) along with annual intake in the institution;
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter;
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to

adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
