ORDER

WHEREAS, recognition was granted to the institution namely Mother Teresa College of Education, MES Ring Road, Jalahalli, Bangalore-560013, Karnataka run by Jalahalli Education Society, Bangalore, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/APSO2086/B.Ed/2004-2005 dt. 25.11.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, the institution has submitted an affidavit on 14.01.2015 for offering B.Ed course with an intake of 100 students. The revised order was issued to the institution on 27.05.2015 with an intake of 100 students.
- 3. AND WHEREAS, on 23.06.2015, the institution has submitted a letter with request for one basic unit of 50 students. A Corrigendum was issued to the institution for one unit on 01.07.2015.
- **4. AND WHEREAS,** the SRC after long deliberation finally considered the case of the institution in its 374^{th} meeting held on $09^{th} 10^{th}$ April, 2019 and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Institution has not submitted the following documents:-

Land Use Certificate issued by the Competent Authority.

Non Encumbrance Certificate issued by the Competent Authority.

 A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)

Building Completion Certificate as per prescribed Format.

 Staff list duly approved by the affiliating body as per the prescribed Format as per provisions of the NCTE Regulations 2014 amended from time to time.

The Committee decided to withdraw the recognition u/s 17 of the NCTE Act, 1993

- **5. AND WHEREAS,** as per the decision of SRC, a Withdrawal order no. F.SRO/NCTE/APSO2086 /B.Ed/KA/2019/103790-3796 dated 26.04.2019 was issued to the institution.
- 6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.91-31st/32nd Mtg./2019-/Appeal/84197 dated 07.11.2019 and the Council confirms the Order appealed against. The operative part of the Appeal order is as under:-

"AND WHEREAS the committee, noting the appellant submitted the documents found wanting in the withdrawal order, concluded that the matter deserved to be remanded to the SRC with a direction to consider the documents, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the SRC the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

AND WHEREAS, after perusal of the memorandum of appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded to remand back the case to the SRC with a direction to consider the documents, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the SRC the documents submitted in appeal, with original thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

NOW THEREFORE, the Council hereby remands back the case of Mother Teresa College of Education, MES Ring Road, Jalahalli, Bangalore, Karnataka to the SRC, NCTE, for necessary action as indicated above."

7. AND WHEREAS, the institution vide letter dated 19.11.2019 submitted. The SRC in its 382nd meeting held on 26th – 27th November, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Mother Teresa College of Education, MES Ring Road, Jalahalli, Bangalore-560013, Karnataka for B.Ed programme for 1 unit of 50 students.

8. NOW THEREFORE, this order is issued permitting the institution i.e. Mother Teresa College of Education, Sy. No. 16/4, Ward No.2, MES Road, Bahubali Nagara, Jalahalli, Bruhat Bangalore Mahanagara Palike, Karnataka run by Jalahalli Education Society, MES Road Bangalore-13, Karnataka for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (one unit) of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students:

- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
