Whereas, the recognition was granted to the institution, namely Excel College of Education, No. 3/28, Agraharam Village, Salem Main Road, Komarapalayam, Namakkal District, Tamilnadu run by Sri Rengaswamy Educational Trust, Komarapalayam, Namakkal District, Tamilnadu for conducting Secondary(B.Ed.) course of one-year duration with an intake of 100 students on 10.08.2006 with the condition to shift to own premises within 3 years.

And Whereas, the SRC in its 215<sup>th</sup> meeting held on 12-13 December 2011 permitted to Shift its premises to the new location/building at Excel College of education NH-47, Salem Main Road, Pallakapalyam-637303, Namakkal, Tamilnadu for B.Ed. Course dt. 05.03.2012.

Whereas, the recognition was granted to the institution, namely Excel College of Education, Plot/Khasara No. 368/8, NH-47, Pallakkapalayam Villae, Sankari West Post, Tiruchencode taluk, Komarapalayam City, Namakkal District-637303, Tamilnadu run by Sri Rengaswamy Educational Trust, Komarapalayam, Namakkal District, Tamilnadu for conducting B.Ed.-AI of two-year duration with an intake of 100 students on 03.03.2015.

And Whereas, after promulgation of NCTE Regulations, 2014, the institution submitted a notarized affidavit dated 01.04.2015 for B.Ed. course and on dt. 01.04.2015 for B.Ed.-AI course consented to come under new Regulations.

And Whereas, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 31.05.2015 to for conducting B.Ed. course of two years duration with an annual intake of 100 students [Two basic units of 50 students each] and for B.Ed. additional intake RPRO was issued on dt. 06.05.2015 for conducting two years duration with an annual intake of 100 students [Two basic units of 50 students each] from the academic session 2015-2016.

And Whereas, the compliance submitted by the institution on dt. 25.11.2019 was considered by the SRC in its 382<sup>nd</sup> Meeting held on 26<sup>th</sup> & 27<sup>th</sup> November 2019.

Now Therefore, the SRC decided to permit the institution i.e. Excel College of Education, Plot/Khasara No. 368/8, NH-47, Pallakkapalayam Villae, Sankari West Post, Tiruchencode taluk, Komarapalayam City, Namakkal District-637303, Tamilnadu for B.Ed. run by Sri Rengaswamy Educational Trust, Komarapalayam, Namakkal District, Tamilnadu-637303 for continuation of recognition for B.Ed. course of two year duration with an intake of 200 students (four units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
  8. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
  9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
    - a. Sanctioned programme(s) along with annual intake in the institution:
    - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
    - c. Name of faculty members who left or joined during the last quarter:
    - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
    - e. Fee charged from students;
    - f. Available infrastructural facilities;
    - g. Facilities added during the last quarter;
    - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
    - i. The affidavit with enclosure submitted along with application.
    - j. The institution shall be free to post additional relevant information, if it so desires.
    - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
  10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
