WHEREAS, recognition was granted to the institution namely Mahathma Gandhi B.Ed College, CA 3 & 4, Adhishakthi Road, Shakthi Nagara, Alanahally, Mysore-570019 Karnataka run by Mahathma Gandhi Trust, # 106, 1st Floor, Raghavendra Building, N.S Road, Near Shanthala Theater, Mysore - 570019, Karnataka vide SRC (NCTE) order no. F.SRC/NCTE/2009/B.Ed/RO/14575 dated 15.07.2009 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, a letter dated 15.11.2012 requesting not to allot Government seats to the College was received on 19.11.2012. The SRC in its 236th meeting held on 16th 17thDecember 2012 considered the reply of the institution and all the relevant documentary evidences and decided to serve Show Cause Notice under NCTE Act, for the following:
 - Local Inquiry Committee, University of Mysore, Mysore which conducted affiliation inspection recommended not to continue affiliation for the Mahatma Gandhi B.Ed College, Mysore for the year 2012.13. The recommendation of the committee was approved by the university Authorities; the Government Karnataka has approved the decision not to continue affiliation for Mahatma Gandhi B.Ed college Mysore for the year 2012-13. Hence, the said college has been informed not to make admission for the year 2012-13.
- 3. AND WHEREAS, a show cause notice was issued to the institution on 05.02.2013. The institution submitted a written representation on 20.02.2013. The SRC, in its 241st meeting held on 29th to 31st March and 01st April, 2013 considered the reply of the institution vide letter dated 20.02.2013 and other related documents, along with the original file of the institution and decided to continue recognition and restore recognition accorded to the institution. Accordingly, order was issued to the institution on 16.05.2013.
- 4. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dated 19.01.2015 consented to come under new Regulations. Thereafter, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 16.05.2015 Mahathma Gandhi Trust, CA 3 & 4, Adhyayana Building, AdiShakti Road, Shakti Nagara, Alanahally, Mysore District 570019, Karnataka for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2016-17 subject to fulfilment of conditions mentioned therein.

5. AND WHEREAS, the Institution submitted documents as per revised recognition order on 30.10.2015. The SRC in its 314th meeting held during 27th& 28thMay 2016 decided as under:

"For Cases of B.Ed (2 units) in the existing institution, where RPRO, had been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f 2016-17 to enable them to make admissions in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of waiting for that action to be completed for placing them before the SRC, to save time, VT Inspection can straightaway be ordered. VT Inspection Reports can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The Institutions concerned may be alerted about such action so that they will be prepared to receive the Visiting Teams. They may also be advised to keep in readiness latest approved Faculty Lists for submission to the VTs."

- **6. AND WHEREAS,** the SRC considered the matter of the institution in subsequent meetings and finally decided its 324th meeting held during 07th -08th December, 2016 considered the matter and decided as under: -
 - 1. There is no need of inspection in this case.
 - 2. Ask the applicant to furnish all relevant documents.
 - 3. Process. And. Put up.
- **7. AND WHEREAS,** as per the decision of SRC, a letter was issued to the institution on 16.12.2016. The institution not submitted reply till date. The SRC, in its 371st meeting held during 25th to 26th February 2019 considered the matter and decided to issue SCN again. As per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution vide letter dated 15.03.2019 submitted reply to the show cause notice. The SRC, in its 379st meeting held during 21st to 22nd August 2019 considered the matter and decided to issue Final Show Cause Notice.
- **8. AND WHEREAS,** as per the decision of SRC a Final Show Cause Notice was issued to the institution on 28.08.2019. The institution vide letter date 14.09.2019 submitted its reply to the Final Show Cause Notice. The SRC in its 382nd meeting held on 26th 27th November, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records made available in the file. The Committee decided that the continuation order be issued to Mahathma Gandhi B.Ed College, Ca 3 & 4, Adhishakthi Road, Shakthi Nagara, Alanahally, Mysore-570019 Karnataka for B.Ed programme for 2 units (50 students each unit).

9. NOW THEREFORE, this order is issued permitting the institution i.e. Mahathma Gandhi B.Ed College, CA 3 & 4, Adishakthi Road, Shakthi Nagara, Alanahally, Mysore-570019

Karnataka run by Mahathma Gandhi Trust ® # 106, 1st Floor, Raghavendra Building, N.S. Road, Near Shanthala Theater, Mysore, Karnataka for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 students each subject to fulfillment of the following conditions:

- 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.

- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
