WHEREAS, DBHPS Dr.B.D. Jatti College of Education, AfzalpurTakke, Bijapur - 506102, Karnataka was granted recognition by SRC for offering B.Ed. course with an intake of 60 students from the session 2000-2001 vide order dated 10.07.2000.

AND WHEREAS, the SRC considered the matter of the institution in details in its 352nd meeting held during 04th & 05th January, 2018 considered the matter and decided as under;

1. The details of the petition are noted.

2.1. This office is not mandated to go into issues relating to equivalence of courses/degrees/certificates. DBHPS should approach the NCTE (HQ) for that.

2.2 The Communications addressed to this office in this connection have already been forwarded to NCTE (HQ) for appropriate further action.

No inspection is required in this B.Ed case.

4.1. Process the documents as an RPRO case.

4.2. Give priority to new application cases. RPRO cases can be taken up after 15 March ie., after we clear the new cases before expiry of the time-limit prescribed by the Supreme Court for issue of FR w.e.f. 2018-19.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice to all such institutions which have not submitted compliance to the RPRO. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 10.07.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, the SRC in its 381st meeting held during 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.11.2019. The institution vide letter dated 05.12.2019 submitted its reply to the Final Show Cause Notice along with the documents. The SRC in its 383rd meeting held during 07th to 09th January, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution on 05.12.2019 in respect of Final Show Cause Notice. The Committee decided that the

continuation order be issued to DBHPS Dr.B.D. Jatti College of Education, Karnataka for B.Edprogramme for 2 units (50 students each unit).

NOW THEREFORE, this order is issued permitting the institution i.e. DBHPS Dr. B.D. Jatti College of Education, Survey No. 744/J, Afzalpur Takke, Bijapur-506102, Karnataka run by Dakshina Bharat Hindi Prachar Sabha, D.C. Compound, Dharwad, Karnataka for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 each subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

The institution shall submit to the Regional Committee as Self - Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- i. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
