ORDER

WHEREAS, recognition was granted to the institution namely **Gayathri College of Education, Wanaparthy Revenue division # 44-35/1, KDR Nagar, Wanaparthy Mahabubnagar District-509103, Telangana** run by **Gayathri Educational Society, Thadiparthy (Village) Gopalpet (Mandal) Mahabub nagar District. Telangana** vide SRC (NCTE) order no. F.AP/NEW/B.Ed/159/SRO/NCTE/2002-2003/6123 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, the institution submitted shifting proposal dated 08.08.2006 along with DD of Rs.40,000/- bearing No.691076 dated 26.09.2006 on 17.10.2006. A letter was sent to the institution on 29.05.2009 regarding submission of documents for shifting.

3. **AND WHEREAS**, on 02.02.2015, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students. Accordingly a revised recognition order was issued to the institution on **11.05.2015** with an annual intake of 100 students of two basic units of 50 students each.

4. **AND WHEREAS**, as per the decision of SRC taken in its 315th meeting held on 17-18th June, 2016, an inspection of the Institution was conducted on 17.08.2016. The same was considered by the SRC in its 321st meeting held on 28th & 30th September, 2016 considered the matter decided to issued show cause notice. As per the decision of SRC show cause notice was issued to the institution on 17.10.2016.

5. **AND WHEREAS**, the institution vide letter dated 27.10.2016 submitted reply to the show cause notice. The SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution on 05.11.2019 The institution vide letter dated 11.12.2019 submitted reply to the First Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 383rd meeting held on 07th to 09th considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the original documents and records submitted by the institution on 12.12.2019 in respect of Show Cause Notice. The Committee decided that the **continuation order** be issued to **Gayathri College of Education, Telangana for B.Ed programme for 2 basic units (50 students each unit) .**

7. NOW THEREFORE, this order is issued permitting the institution i.e. **Gayathri College of Education, Sy. No. 261/2, Thadiparthi (village) Gopalpet (Mandal) Mahabub nagar District-509206, Telangana** run by **Gayathri Educational Society, Thadiparthi (Village) Gopalpet (Mandal) Mahabub nagar District. Telangana** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 students each subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:

- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications; scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
