WHEREAS, recognition was granted to the institution namely Taj College of Education, Shaik Roja, Behind Chechpost, Aland Road, Gulbarga District-585101, Karnataka run by Karnataka Education and Welfare Trust, Gulbarga District, Karnataka vide SRC (NCTE) order no. F.SRC/NCTE/B.Ed/2005-2006/5060 dt. 03.01.2006 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 30.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 29.05.2019. The institution did not submitted reply to the SCN.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decided taken in 380th meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a Final show cause notice was issued to the institution on 11.10.2019. The institution vide letter dated 02.11.2019 submitted its reply to the Final show cause notice along with the documents:-

AND WHEREAS, the SRC in its 383nd meeting held on 07th to 09th January, 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 29.05.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 11.10.2019. The institution vide letter dated 02.11.2019submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-

- > The LUC submitted by the institution was not approved by the competent authority. Conversion of Land for Education Purpose was not mentioned. The LUC was not in favour of Trust / Institution.
- > The NEC was not submitted duly approved by the competent authority.
- > The institution has not submitted original blue-prints of building plan. The copy of BP submitted which is not in favour of Trust / Institution. The approving authority also not mentioned.

- > Site plan submitted by the institution was not approved by the competent authority.
- > The BCC submitted by the institution was not in prescribed format.
- The institution submitted photocopy of Staff list (1+11) countersigned by Principal, Karnataka Educational & Welfare Trust and countersigned by Registrar, Gulbarga University. Date of appointment has not been shown in the staff list. The institution has not appointed faculty for Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Taj College of Education, Shaik Roja, Behind Chechpost, Aland Road, Gulbarga District-585101, Karnataka for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
