WHEREAS, the recognition was granted to the institution namely, Holy Faith Minority College of Edcution, Khammam Revenue Division Kistrarm, Sathupally, Kahammam District, Andhra Pradesh vide SRC vide order no. F.AP/NEW/B.Ed./185/SRO/NCTE/2002-2003/7967 dt. 03.07.2003 for (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2: AND WHEREAS, the SRC vide order no. F.No.APS00250/B.Ed./TN/2011-12/30029 dt. 29.08.2011 was issued to the institution for shifting of premises to new location at Survey no. 293/1-2, 283, Kistharam, Sthupalli, Andra Pradesh-507303.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- 4. **AND WHEREAS**, on the basis of request, the SRC in its 342nd meeting held on 05th & 06th July, 2017 the matter was considered and decided for reduction of intake from 2 units to 1 unit vide order no. F.No.SRO/NCTE/APS00250/B.Ed./TS/2017-18/94107 on 21.07.2017 reduction of intake of 2 units to 1 unit.
- 5. AND WHEREAS, the matter regarding compliance by the institutions where 1 unit was granted to an institution was placed before the SRC in its 375th Meeting held on wherein the SRC decided to issue SCN to all such institutions (one unit or two or more units cases) asking to submit details regarding additional facilities, additional infrastructure, additional infrastructure, additional fund, additional staff as per Regulations, 2014 and other documents such as land documents, EC, LUC, BP & BCC etc. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 25.09.2019. The institution has submitted reply on 12.12.2019.
- 6. AND WHEREAS, the SRC in its 389th Meeting held on 12th to 14th October 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 21.10.2020. The institution has submitted reply on 08.02.2021.
- 7. AND WHEREAS, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993 Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 08.02.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The building plan is not properly readable and the size of classroom and Multipurpose Hall, No. of toilets etc are submitted.
- 2. The institution has not submitted Form "A" in original.
- 3. The date of appointment of faculty are not mentioned to assertion eligibility.
- 4. A copy of degree of Ph.d./letter of affiliating University is not submitted towards appointment of Principal and other faculty as applicable from time to time.
- 5. One faculty for Health and Physical Education/Fine Arts/ Performing Arts is not appointed.
- 6. Date inspection if Building is not mentioned in B.C.C.

Hence, the Committee decided to withdraw the recognition granted to Holy Faith Minority College of Education, Sy. No. 293/1-2, 283 Kistharam, Sathupalli – 507303, Telangana for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Holy Faith Minority College of Education, Sy. No. 293/1-2, 283 Kistharam, Sathupalli 507303, Telangana run by Holy Faith Minority Educational Society (Christian Minority), Reg. no. 2895/2001, R/o Sathupalli, Khammam District, Telangana for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
