CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely Adhuyaman College of Education for Women, Srinivasanagar, Krishnagiri Main Road, Uthanagarai Post, Krishnagiri District — 635207, Tamilnadu vide SRC (NCTE) order no. F.No.SRO/NCTE/SRCAPP1783/B.Ed./TN/2015/62218 dated 03.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016.

- 2. AND WHEREAS, the SRC in its 323rd meeting held on 16th to 18th November 2016, considered the matter and decided to issued show cause notice. Accordingly, a Show Cause Notice was issued to the institution on 30.11.2016.
- 3. AND WHEREAS, a letter received from NCTE-Hqrs and an e-mail 19.12.2016 from Ms. Priyanjali Singh, advocate supreme court with the request to furnish parawise remarks in respect of Adhiyaman College of Education, in W.P. No. 746 and 747 of 2014. Accordingly, a letter was sent to advocate, Ms. Priyanjali Singh along with brief on 20.12.2016.
- 4. AND WHEREAS, SRC in its 351st meeting held on 28th to 29th December 2017 and the committee considered and decided to issue Show Cause Notice. As per the decision of SRC Show Cause Notice was issued to the institution on 16.01.2018. The institution has submitted a reply received by this office on 29.01.2018, along with faculty list.
- 5. AND WHEREAS, the SRC in its 358th meeting held on 01st 03rd March, 2018 considered the matter and decided to issue a Reminder letter. Accordingly, a Reminder letter was issued to the institution on 06.03.2018. The institution vide letter dated 24.05.2018 submitted reply to the letter.
- 6. AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued on 24.09.2020. The institution vide letter dated 09.10.2020 submitted reply to the Show Cause Notice.
- 7. AND WHEREAS, the matter was further considered by the SRC in its 395th meeting held on 25th-26th February 2021 and the Committee decided to issue Final Show Cause Notice to the institution. Accordingly, Final Show Cause Notice was issued on 08.03.2021. The institution vide letter dated 04.03.2021 submitted its reply to the Final Show Cause Notice.

8. AND WHEREAS, the matter was placed before the SRC in its 397th meeting held on 25th – 26th March 2021 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution and decided that the continuation order be issued to the Institution Adhuyaman College of Education for Women, 15/1B3B, 15/1A3B Srinivasa Nagar Koorasampatti Village Naralapalli Panchayat Uthangarai TK, Krishnagiri District-635207, Tamilnadu for B.Ed. programme for 2 basic units of 100 students.

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Adhuyaman College of Education for Women, 15/1B3B, 15/1A3B Srinivasa Nagar Koorasampatti Village Naralapalli Panchayat Uthangarai TK, Krishnagiri District-635207, Tamilnadu run by Srinivasa Educational Trust, Adhiyaman Nagar, Uthanagarai Post Office & Taluk, Krishnagiri District 635207, Tamilnadu for Continuation of recognition for B.Ed. programme for 2 basic units of 100 students subject to fulfilment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

I. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- Available infrastructural facilities;
- Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
