**CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely **St. Lawrence College of Education, Khammam District – 507163, Andhra Pradesh** run by **St. Lawrence Educational Society, Khammam District – 507163, Andhra Pradesh** vide SRC (NCTE) order No. F.AP/NEW/B.Ed/193/NCTE/2002-2003/7969 dated 03.07.2003 for B.Ed. Course of one-year duration from the academic session 2002-2003 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 321<sup>st</sup> meeting held on 28<sup>th</sup> – 29<sup>th</sup> September, 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 24.10.2016.

4. **AND WHEREAS**, the SRC in its 381<sup>st</sup> meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly a Final Show Cause Notice was issued on 25.11.2019. The institution vide letter dated 13.12.2019 submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> December, 2020 and the Committee decided to withdraw the recognition. Accordingly withdrawal order No.F.SRO/NCTE/APS00291/B.Ed/TS/2020/121269-1274 dated 18.12.2020 was issued to institution.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-02/E-17583/2021 Appeal/7 Mtg-2021/23<sup>rd</sup> February, 2021 dated 12.03.2021 appeal remand back the Order appealed against. The institution vide letter dated 13.03.2021 submitted reply to the appeal remand back.

7. **AND WHEREAS**, the SRC in its 397<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> March, 2021 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents



furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution and decided that the **continuation order** be issued to the Institution **St. Lawrence College of Education, Survey No. 133/1, Arempula Village, Khammam Rural, Khammam District-507163, Telangana** for B.Ed programme for **2 basic units of 100 students**.

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. **St. Lawrence College of Education, Survey No. 133/1, Arempula Village, Khammam Rural, Khammam District-507163, Telangana** run by **St. Lawrence Educational Society, Arempula (v), Khammam Rural mandal, Khammam District-507163, Telangana** for continuation of recognition for B.Ed. course of two years duration with an intake of 100 students (**2 basic units**) of subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:



- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
