WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Mata Amirtanandamayi Math, Bogadi Village, #114, 7<sup>th</sup> Cross, Bogadi II Stage, Mysuru Town and City, Mysore Distict-570026, Karnataka run by Amrita Vishwa Vidyapeetham, Ettimadai Village, Amrita Nagar Street, Coimbatore Taluk and Mandal, Ettimadai Town, Coimbaore District- 641112, Tamilnadu** vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP201630043/B.Sc.B.Ed/KA/2017-18/96434 dated: 16.01.2018 for conducting B.Sc.B.Ed course of four-years duration with an annual intake of (1 unit) 50 students.

**AND WHEREAS**, the SRC in its 366<sup>th</sup> meeting held on 3<sup>rd</sup>-4<sup>th</sup> Dec., 2018 decided to issue SCN to the institution on the following grounds:-

1. This is a case in which we had made a mistake of giving recognition without realizing that the amendment to the Regulations on 09.06.2017 had been violated by this college.
2. Seven faculty members do not have NET/Ph.D degree as per taken as per NCET Act & Regulation 2014.

Therefore, in compliance of the decision of the SRC this show cause notice (SCN) u/s 17 (1) of NCTE Act, 1993 is issued to the institution with directions to submit written representation with in a period of 30 days from the date of issue of this notice, complying the decision of the SRC, failing which action u/s 17 (1) will be taken as per NCTE Act & Regulation 2014.

**AND WHEREAS**, as per the above decision of the SRC a SCN No. F.SRO/NCTE/SRCAPP 201630043/KA/2020 dated 12.12.2019 was issued to the institution.

**AND WHEREAS**, the SRC in its 383<sup>rd</sup> Meeting held on 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> January 2020 considered the matter and decided as under:-

The Committee decided that to **withdraw the recognition granted to Amrita School of Education, No.114, 7<sup>th</sup> Cross, Bogadi 2<sup>nd</sup> Stage, Mysure-570026 Karnataka** for conducting B.Ed & B.Sc. B.Ed (Integrated) courses under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 09.12.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
