#### **ORDER**

WHEREAS, the recognition was granted to the institution namely Vinukonda B.Ed College, Narasaraopet, Revenue Division, No.30-290, NRT Road, Vinukonda, Guntur District -522647, Andhra Pradesh run by Vasavi Educational Society, Vinukonda-522647, Guntur District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/123/SRO/NCTE/2002-2003/6114 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the SRC in its 217th meeting held on 8th 9th February, 2012 2. considered the reply of the institution vide letter dated 05.08.2011 and all other relevant documentary evidence and decided to allow for shifting of the institution to the new premises at Vinukonda B.Ed College, Sy.No.72,65/1-1A, 65/1-1B, 65/1-1-2, Kanamarlapudi Village, Savalayapuram Mandal, Vinukonda – 522646, Guntur District, Andhra Pradesh. As per the decision of SRC, shifting of premises order was issued to the institution on 07.03.2012.
- AND WHEREAS, the matter was placed before SRC in its 275th Meeting held on 01st. 02<sup>nd</sup> December, 2014 considered the matter, decided to defer for consideration with respect to the new Regulations that are being notified by the NCTE (H'qrs). Further, advised Southern Regional Office to put up in the next meeting.
- AND WHEREAS, the institution has submitted affidavit as per the regulation 2014 on 19.01.2015. Accordingly, revised recognition order was issued to the institution on 15.05.2015 at the time of issuance of revised order it is found that, as per the letter of Acharya Nagarjuna University, dated 27.10.2014, the institution is functioning at different address and the matter is pending with this office. The institution submitted written representation along with documents on 09.07.2015. The SRC in its 321st meeting held on 28th & 29th September, 2016 considered the matter and decided as under;

  - 8. Fee not paid.
  - Collect fee and cause inspection.
  - 10. Ask VT to collect all relevant documents and check on the deficiencies listed.

- AND WHEREAS, as per decision of SRC a letter was sent to the institution on 08.11.2016. The SRC in its 343rd meeting held on 01st & 02rd August, 2017 considered the requesting for inspection and decided as under;
- These are RPRO cases. In view of the latest instructions, no inspection is required 1 A - 1 \ 2.
  - But, these also involve 'shifting'. Therefore, VT Inspection will be required.
  - The SRO's request is noted and permission is given for organizing VT Inspections in these cases.
  - AND WHEREAS, the SRC already allowed the institution for shifting of the institution to the new premises at Vinukonda B.Ed College, Sy.No.72,65/1-1A, 65/1-1B, 65/1-1-2, Kanamarlapudi Village, Savalayapuram Mandal, Vinukonda - 522646, Guntur District, Andhra Pradesh. As per the decision of SRC, shifting of premises order was issued to the institution on 07.03.2012.
  - AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue First SCN. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 06.12.2019. The institution vide letter dated 06.01.2020 submitted reply to the First SCN. The SRC in its 384th meeting held on 12th -13th February, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee decided that the continuation order be issued to the Institution Vinukonda B.Ed College, Guntur District - 522647, Andhra Pradesh for B.Ed programme for 2 basic units (50 students each unit).

- NOW THEREFORE, this order is issued permitting the institution i.e. Vinukonda B.Ed 8. College, Sy.No.72,65/1-1A, 65/1-1B, 65/1-1-2, Kanamarlapudi Village, Savalayapuram Mandal, Vinukonda - 522646, Guntur District, Andhra Pradesh run by Vasavi Educational Society, Sy.No. 65/1-1-A, 65/1-1-B, 65/1-1-2,72, Vasavi Nagar, Kanamarlapudi Village, Savalyapuram Mandal, Vinukonda, Guntur District - 522647, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 units) of subject to fulfillment of the following conditions:-
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - The institution shall comply with the various other norms and standards prescribed in П. the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself

vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
