ORDER

WHEREAS, the recognition was granted to the institution, namely **Goutham College of Education, No. 258, 5th Main, 2nd Cross, West of Chard Road, Rajaji Nagar, Bangalore-560010, Karnataka** run by **Goutham Institute of Medical Science & Technology, Bangalore, Karnataka** vide order no. F.SRO/NCTE/APSO1725/B.Ed/2005-2006/5295 dt. 31.01.2006 for conducting B.Ed course of one year duration with an intake of 100 students.

2. **AND WHEREAS**, the inspection of the institution was conducted under Section 13 of NCTE Act for B.Ed. and M.Ed. coursed and the matter was considered by the SRC in 203rd Meeting of the SRC and decided to withdraw the recognition of the institution. Accordingly, SRC issued a Withdrawal Order No. F.No. SRO/NCTE /APSO1725/APSO7399/2011-2012/28519 to the institution on 09.05.2011.

3. **AND WHEREAS**, aggrieved with the decision of the SRC, the institution filed an Appeal before the Appellate Authority and the Appellate Authority vide Order dated 4.11.2011 issued direction to the SRC for re-examination of the case in the light of observation of the Council and pass appropriate order.

4. **AND WHEREAS**, the SRC in its 216th meeting held on 11-12th January 2012 considered the reply of the institution and VT report of the institution, VCD and other relevant documents and decided to restore recognition accorded to the institution for B.Ed. & M.Ed. course. Accordingly the SRC issued a Recognition Order No. F.No.SRO/NCTE /APSO1725/APSO7399/2011-2012/37296 to the institution on 10.02.2012.

5. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 09.06.2015 for its willingness for adherence of provisions of new Regulations. A provisional revised recognition order was issued to the institution on 01.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.

6. **AND WHEREAS**, in compliance of the decision of the RC taken in its 369th meeting the SRC issued a SCN dated 16.5.2019. However the institution did not submit its reply to SCN. Subsequently, the SRC in its 380th meeting considered the matter and decided to issue final show cause notice to the institution. Accordingly, as per the decision of SRC a final show cause notice was issued to the institution on 09.10.2019. The institution submitted its reply to the final show cause notice on 06.02.2020.

7. **AND WHEREAS**, the SRC in its 384th meeting held on 12th – 13th February 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee decided that the **continuation order** be issued to the Institution Goutham College of Education, Bangalore-560010, Karnataka for **B.Ed** programme for 1 **basic unit of 50 students**.

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Goutham College of Education, No. 258, 5th Main Road, Manjunath Nagar I Stage, West of Chord Road, Rajajinagar, Bangalore-560010, Karnataka** run by **Goutham Institute of Medical Science & Technology, Bangalore, Karnataka** for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (**one basic unit**) of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
13. The institution shall make available the list of students admitted on its official website.
14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
