ORDER

WHEREAS, the recognition was granted to the institution namely **H.K.D.E. Trust's College of Education, Kalloor Road, Humnabad, Bidar District – 585330, Karnataka** run by **Hyderabad Karnataka Development Education Trust, Humnabad, Bidar District, Karnataka** vide SRC (NCTE) order no. F. SRO/NCTE/APSO1958/B.Ed/2004-2005/8907 dt. 30.11.2004 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on 22.01.2015 the institution submitted an affidavit affirming adherence to Regulations, 2014. A revised order was issued to the institution on **27.05.2015** for offering B.Ed. course of two years duration from the academic session **2015-16** with an intake of two units of 50 students each.

3. **AND WHEREAS**, as per the decision of the SRC an inspection of the institution was conducted on 14.10.2016 and the VT report received on 22.10.2016.

4. **AND WHEREAS**, the SRC in its 363rd meeting held during 17th – 19th September, 2018 considered the visiting team report and decided to issue show cause notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 22.11.2018. The institution has submitted reply to the Show Cause Notice vide letter dated 11.12.2018. The SRC in its 370th meeting held on 07th -08th February, 2019 considered the matter and decided to issue show cause notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 15.02.2019. The institution has submitted reply to the Show Cause Notice vide letter dated 08.03.2019 received in office on 11.3.2019.

5. **AND WHEREAS**, the SRC in its 375th meeting held on 13th – 14th May, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The matter was discussed in detail and the SRC decided to issue continuance of recognition subject to submission of clarification from the affiliating university about the appointment of mathematics lecturer.

6. **AND WHEREAS**, as per the decision of SRC a letter was issued to the University on 24.05.2019. A letter dated 08.07.2019 received 17.07.2019 in this office SRC, NCTE from the University informing them the following:-

"...With reference of the above matter we are here by giving clarification regarding the appointment of Shri. Prashant Siddlaingappa Mathematics Lecturer of HKDE Trust's College of Education, Humnabad (Karnataka) that, his date of appointment is 18.01.2018 only as mentioned in their appointment order and not 15.05.2015 as mentioned in the faculty list submitted to you vide letter dated: 08.03.2019."

7. **AND WHEREAS**, The SRC in its 380th meeting held during 18th – 19th September, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 01.10.2019. The institution vide letter dated 15.10.2019 submitted its reply to the Final Show Cause Notice. The SRC in its 384th meeting held on 12th – 13th February 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee decided that the **continuation order** be issued to the Institution H.K.D.E. Trust's College of Education, Kalloor Road, Humnabad, Bidar District – 585330, Karnataka for **B.Ed programme for 2 basic units (50 students each unit)**.

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. **H.K.D.E. Trust's College of Education, Sy.No. 296/3a, Humnabad, Bidar District – 585330, Karnataka** run by **Hyderabad Karnataka Development Education Trust, Humnabad, Bidar District, Karnataka** for continuation of recognition for B.Ed course of two years duration with an intake of **100 students (Two basic units)** of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
