**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **V.M. Lingaiah College of Education, Somnahalli, Maddur Taluk, Mandya District- 571429, Karnataka** run by **Somanahalli Education Society, Somanahalli, Maddur Taluk, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/APSO1981/2004-2005/9126 dt 03.12.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on 22.01.2015, the institution submitted an affidavit expressing willingness towards adherence to Regulations 2014. A revised recognition order was issued to the institution on 26.05.2015 with an intake of 100 students with two basic units of 50 students each.

**AND WHEREAS**, a letter dated 31.07.2015 was received by this office from the institution and had sought one month time to submit the documents. A letter along with documents was received by this office from the institution on 24.09.2015 along with inspection fee of Rs. 1,50,000/-.

**AND WHEREAS**, the SRC in its 298<sup>th</sup> meeting held during 08<sup>th</sup> to 10<sup>th</sup> January, 2015 considered the matter and decided as under:-

1. Cause Composite inspection
2. Fee for B.Ed Paid
3. Built up area is inadequate for B.Ed and D.El.Ed in fact, it is adequate only for one unit of B.Ed
4. Ask VT to collect all relevant documents and check adequacy of built up area.

**AND WHEREAS**, as per the decision of SRC, a letter was issued to the institution on 13.07.2016. The institution has submitted a request letter for one unit on 12.07.2016. The SRC, in its 322<sup>nd</sup> meeting held during 20<sup>th</sup> to 21<sup>st</sup> October, 2016 considered the matter and decided to issue show cause notice on the following points :-

1. The request for reduction from B.Ed (2 units) to B.Ed (1 unit) is accepted.
2. EC is in order.
3. LUC is not approved by competent authority.
4. BP – not approved by competent authority.
5. BCC is approved. But built –up area is inadequate even for one unit of B.Ed.

**AND WHEREAS**, as per the decision of SRC, a Show Cause Notice was issued to the institution on 07.11.2016. The institution has a reply to the Show Cause Notice on 28.11.2016. The SRC in its 351<sup>st</sup> meeting held during 28<sup>th</sup> – 29<sup>th</sup> December, 2017, considered the matter and decided as under:-

1. This is an old institution running D.El.Ed and B.Ed programmes w.e.f. 2004.

- 2.1 LUC has to be authenticated by a Revenue Officer. Every village is covered by a revenue officer.
- 2.2 Explanation regarding BP is accepted.
- 3.1 They have requested for 6 months time to augment built-up area.
- 3.2 Simultaneously, they have also requested for permission to shift.
- 3.3 It is not clear what exactly the intention.
4. All the documents given are to the old site. This action does not match with the request for shifting. Ask them to clarify this contradiction.
5. FDRs are not there.
6. Faculty list not given.
7. Issue SCN.

**AND WHEREAS**, as per the decision of SRC, a Show Cause Notice was issued to the institution on 05.01.2018. On 31.01.2018, the institution has submitted a letter dated 27.01.2018. But till date the institution has not submitted show cause notice reply. The SRC in its 360th meeting held during 23<sup>rd</sup> to 24<sup>th</sup> May, 2018 considered the matter and decided as under;

1. They have still not complied with all the points raised by us.
2. Obviously, there has been some ambiguity in communication.
3. This is a shifting case. And, they are giving documents/information regarding the old site I.
4. They have asked for more time. Give time till 31.7.18.

**AND WHEREAS**, as per the decision of SRC a letter was issued to the institution on 25.05.2018. The SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 1<sup>st</sup> Nov, 2019 considered the matter and decided to issue Final SCN in all such matters where the institution has not submitted the requisite document in response to RPRO issued by SRC. Therefore, the institution is required to submit the documents. Accordingly as per the decision of SRC a final show cause notice was issued to the institution on 08.11.2019. The institution vide letter dated 05.12.2019 submitted its reply to the final show cause notice. The SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> -13<sup>th</sup> February, 2020 considered the matter and decided as under- :

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 05.01.2018. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 08.11.2019. The institution vide letter dated 05.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-

1. The institution has submitted Building Plan which is not approved by the competent authority not legible. The size of multipurpose hall, built up area, etc are not mentioned in building plan.
2. The institution has submitted BCC which was approved in regional language. The total built up area is 12812 sq. ft which is insufficient as per NCTE Regulations, 2014.
3. The institution has submitted photocopy of FDR instead of submitting Form A for FDRs towards Endowment and Reserve Fund as per NCTE Regulations.
4. The institution has not submitted latest staff list.
5. The institution has not submitted a copy of the site plan.

Hence, the Committee decided to **withdraw the recognition** granted to **V.M. Lingaiah College of Education, Somnahalli, Maddur Taluk, Mandya District-571429, Karnataka** for conducting **B.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

**NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **V.M. Lingaiah College of Education, Somnahalli, Maddur Taluk, Mandya District- 571429, Karnataka** run by **Somanahalli Education Society, Somanahalli, Maddur Taluk, Karnataka** for conducting **B.Ed.** programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
