### **ORDER**

WHEREAS, the recognition was granted to the institution namely Smt. Manoramabai Bheemarao Huligol College of Education, K.C. Rani Road, Gadag-582101, Karnataka run by Vidya Dan Samiti, Gadag, Karnataka vide SRC (NCTE) order no. F. SRO/NCTE/APSO2151/B.Ed/2004-2005/9042 dt. 02.12.2004 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on 31.12.2014 letter was issued to the institution on affidavit expressing adherence to Regulation 2014. The institution has submitted its written representation along with affidavit on 17.06.2015. The provisional revised order was issued to the institution on 01.07.2015 with an intake of 100 students.
- 3. AND WHEREAS, the SRC considered the case of the institution in its meeting from time to time. The matter of the institution was finally considered by the SRC in its  $375^{th}$  meeting held on  $13^{th} 14^{th}$  May, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Smt. Manoramabai Bheemarao Huilgol College of Education, K.C. Rani Road, Gadag-582101, Karnataka for B.Ed. course on the following grounds: a) The land documents submitted by the institution is on Lease in favour of President

Vidyadan Samiti, Smt M.B. Huilgol (R ) B.Ed College.
b) Certified copy of LUC issued by the competent authority is not submitted.

c) The latest EC is submitted in regional language.

d) Building plan is submitted which is not readable.

e) Faculty list submitted which is not approved by the affiliating university.

- f) FDRs of Rs 8 Lakhs are submitted in photocopy against the requirement of original towards the Endowment and Reserve Fund of Rs 12 Lakh.
- **4. AND WHEREAS**, as per the decision of SRC, a Withdrawal order no. F.SRO/NCTE/APSO2151/B.Ed/KA/2019/104600-4606 dated 21.05.2019 was issued to the institution.
- 5. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.91-29<sup>th</sup>/30<sup>th</sup>/ Mtg./2019-/Appeal/83416 dated 25.10.2019 and the Council remands back the case. The operative part of the Appeal order is as under:-

"AND WHEREAS the Committee, noted that appellant institution is conducting B.Ed. course since the academic session 2004-05. After the 2014 Regulation the appellant has requested for reduction in intake in July, 2017, on which SRC has not taken any decision. The institution continues to function from the same address. Appeal Committee, therefore, decided that appellant institution is required to submit to SRC a complete and comprehensive compliance with authenticated English version of land documents, CLU NEC and legible copy of BCC, building plan.

AND WHEREAS Appeal Committee considered that onus lies on the Regional Committee to have obtained enrolment data from the affiliating university to ascertain the number of students admitted by appellant institution during the preceding years after the issue of revised recognition order. The case is remanded back to SRC for revisiting the matter after obtaining required information from affiliating university, and set of other documents such as (i) Land documents, Building plan, Building Completion Certificate, CLU. Latest Non Encumbrance Certificate and latest list of faculty approved by affiliating university from the appellant institution. Appellant institution is required to submit required documents to SRC within 15 days of the issue of appeal orders.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded that the case deserve to be remanded university, and to be remanded back to the SRC for revisiting the matter after obtaining required information from affiliating university, and set of other documents such as (i) Land documents, Building plan, Building Completion Certificate, CLU. Latest Non Encumbrance Certificate and latest list of faculty approved by affiliating university from the appellant institution. Appellant institution is required to submit required documents to SRC within 15 days of the issue of appeal orders.

NOW THEREFORE, the Council hereby remands back the case of Smt. Manoramabai Bheemarao Huligol College of Education, Gadag, Karnataka to the SRC, NCTE, for necessary action as indicated above."

**6. AND WHEREAS** the SRC in its  $382^{nd}$  meeting held on  $26^{th}-27^{th}$  November, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 10.12.2019. The institution submitted its reply to the Final Show Cause Notice on 10.02.2020. The SRC in its  $384^{th}$  meeting held on  $12^{th}-13^{th}$  February 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply, documents and records submitted by the Institution, Committee also decided that the continuation order be issued to the Institution Smt. Manoramabai Bheemarao Huilgol College of Education, Karnataka for B.Ed programme for 2 basic units (50 students each unit).

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. Smt. Manoramabai Bheemarao Huligol College of Education, Sy.No. 6694/A, Ward No. 28 K.C. Rani Road, Gadag-582101, Karnataka run by Vidya Dan Samiti, Gadag, Karnataka for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (Two basic units) of subject to fulfillment of the following conditions:
  - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;

- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
