WHEREAS, the recognition was granted to the institution namely, Peet Memorial Training Alappuzha Dist, Pin-690101, Kerala vide College, Mavelikara, F.KL/MED/SRO/NCTE/2005-2006/2502 dt. 26.08.2005 for conducting M.Ed. course of one year duration with an annual intake of 25 students.

- AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 was permitted to Peet Memorial Training College, Mavelikara, Alappuzha Dist, Pin-690101, Kerala vide order No. F.SRO/NCTE/2010-2011/20547 on 20.08.2010 from the session 2010-2011.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 3. submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show 4. Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 13.03.2019. The institution has submitted reply on 11.04.2019.
- AND WHEREAS, the SRC in its 383rd Meeting held on 07th 09th January. 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 20.01.2020. The institution has submitted reply on 24.02.2020.
- AND WHEREAS, the SRC in its 408th meeting held on 02nd March, 2022 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a F.SRO/NCTE/APS04020/M.Ed/KL/2022/130851-130855 dated Withdrawal Order no. 14.03.2022 was issued to the institution.
- AND WHEREAS, aggrieved by the withdrawal order, the institution preferred an appeal to NCTE-Hgrs. The Appellate Authority in its order No. 89-111/E-251080/2022 Appeal/5th Mtg.2022 dated 12.07.2022 the Council confirms the Orders appealed/against.
- AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Kerala at Ernakulam bearing W.P(C) No. 24026/2022 vide order dated 29.07.2022 titled as Peet Memorial Training College Versus National Council for Teacher Education & Anr. As per direction of Hon'ble High Court the Petitioner College has submitted representation along with documents on dated which were received in the office on 17.08.2022.
- AND WHEREAS, the SRC in its 413th meeting held on 22nd 23rd August, 2022 considered the matter and decided to issue Final Show Cause Notice to the institution.

Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 05.09.2022. The institution has submitted reply on 09.09.2022.

10. AND WHEREAS, the SRC in its 414th Meeting held on 26th – 27th September, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Peet Memorial Training College, Ward No. 5, Survey No.17/6, Mavelikara Municipality, Mavelikara, Alappuzha District, Kerala-690101 for M.Ed. programme for 1 basic unit of 50 students subject to the condition on submission of an Affidavit on Rs.100/- Non Judicial Stamp paper clearly mentioning the name and account number of each of the faculty appointed for M.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT. The Affidavit should be supported with documents like photocopy of passbook of each of faculty showing the disbursement of salary through bank account to individual faculty members (at-least for 3 months). After receipt of the same the RD, SRC is advised to issue continuation order only after obtaining the above required documents."

- 11. AND WHEREAS, as per decision of SRC a letter was issued to the institution on 11.10.2022. The institution has submitted bank statement vide letter dated 03.11.2022 according, to statement the salary is being disbursed through bank.
- 12. NOW THEREFORE, this order is issued permitting the institution i.e., Peet Memorial Training College, Ward No. 5, Survey No.17/6, Mavelikara Municipality, Mavelikara, Alappuzha District, Kerala-690101 for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **14.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of
