WHEREAS, the recognition was granted to the institution Best College of Education, No. 26/54, Mayura Nathar North Street, Mayiladuthurai, Nagapattinam District, Tamilnadu-609001 run by Ayoob Educational Trust, No. 26/54, Mayura Nathar North Street, Mayiladuthurai, Nagapattinam District, Tamilnadu-609001 vide SRC order No. F.SRO/NCTE/B.Ed./2007-2008/4193 on 26.08.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2008-2009.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit on 27.10.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, on the basis of request, the SRC in its 329th Meeting held on 06th & 07th February 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 11.10.2017 reduction of intake from 2 units to 1 unit.
- AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the 4. matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 05.04.2019. The institution has submitted reply on 10.05.2019 & 25.05.2019.
- AND WHEREAS, the SRC in its 404th Meeting held on 16th & 17th November. 2021 considered the matter and decided to constitute VT. The VT conducted on 06th & 07th January, 2022 and VT report was received on 13.01.2022.
- AND WHEREAS, the SRC in its 406th Meeting held on 19th January 2022 considered 6. the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee on perusal of the reply submitted by the institution namely Best College of Education decided that shifting of premises be permitted to the institution at new address i.e. R-survey No. 36/12, 13, 14, 21, 22, 24, 28, and 38/23, 28, Kumbakonam Main Road, Aanaimelagaram Village, Mayiladuthurai (T.K.) Aanaimelagaram 609806, Tamilnadu. The Committee also decided that

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., Best College of Education to shift its building at new address i.e. R-survey No. 36/12, 13, 14, 21, 22, 24, 28, and 38/23, 28, Kumbakonam Main Road, Aanaimelagaram Village, Mayiladuthurai (T.K.) Aanaimelagaram-609806, Tamilnadu run by Ayoob Educational Trust, R-survey No. 36/12, 13, 14, 21, 22, 24, 28, and 38/23, 28, Kumbakonam Main Road, Aanaimelagaram Village, Mayiladuthurai (T.K.) Aanaimelagaram 609806, Tamilnadu with an order for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 student each subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - Available infrastructural facilities.

- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
