CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution **Chaitanya College of Education, No. 22-108-8, B.C. Road, Pedagantyada, Visakhapatnam District, Andhra Pradesh-530044** run by **Annapurna Educational and Charitable Society, Visakhapatnam District, Andhra Pradesh** vide order No. F.SRO/NCTE/B.Ed./2008-2009/4110 on 22.08.2018 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2008-2009.

2. **AND WHEREAS**, an order no. F. No./APS09328/B.Ed./2011-12/28838 dt. 26.05.2011 for shifting of new premises in respect of B.Ed. course of **Chaitanya College of Education, No. 22-108-8 B.C. Road, Pedagantyada, Visakhapatnam District** to new/permanent premises **Plot no. 1A, P.S. Bonangi Chaitanya Nagar, Parawada, Visakhapatnam, Andhra Pradesh-530021**.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 28.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting **B.Ed. course of two years duration** with an annual intake of 100 students for **two basic units** of 50 students each from the academic session 2015-16.

4. **AND WHEREAS**, a Corrigendum order no. F.SRO/NCTE/APS09328/B.Ed./AP/2015/68060 dt. 22.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016 was issued to the institution.

5. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 25.04.2019. The institution did not submit reply to the Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 10.12.2019. The institution has submitted reply on 01.01.2020.

7. **AND WHEREAS**, the SRC in its 390th Meeting held on 28th & 29th October, 2020 considered the matter and decided to Withdraw the recognition. Accordingly, as per decision of SRC a withdrawal order no. F.SRO/NCTE/APS09328/B.Ed./AP/202020549-0555 dt. 06.11.2020 was issued to the institution.

8. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-18/E-174366/2021Appeal/7 Mtg.-2021/23rd February, 2021 dt. 12.03.2021 appeal remand back the order appealed against.

9. **AND WHEREAS**, the SRC in its 397th Meeting held on 25th & 26th March, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 08.04.2021. The institution has submitted reply on 09.04.2021, 27.05.2021 & 04.01.2022.

10. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Chaitanya College of Education, Survey No. 38/2, P.S. Bonangi, P.S. Bonangi Panchayat, Visakhapatnam-530021, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students.**"*

11. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Chaitanya College of Education, Survey No. 38/2, P.S. Bonangi, P.S. Bonangi Panchayat, Visakhapatnam-530021, Andhra Pradesh** run by **Annapurna Educational and Charitable Society, Survey No. 38/2, P.S. Bonangi, P.S. Bonangi Panchayat, Visakhapatnam-530021, Andhra Pradesh** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
16. The institution shall make available the list of students admitted on its official website.
17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
