WHEREAS, the recognition was granted to the institution namely, Aadya Sri Nijalingeshwar Shikshana Samsthe's B.Ed College, Ananth Vidya Nagar, P.B.No. 16, Sankeshwar-591313, Belgaum District, Karnataka vide order no. F.SRO/NCTE/B.Ed./2005-2006/4828 dt. 21.12.2005 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, a letter was issued to the institution on 09.12.2009 regarding Change of Name from "Adya Shri. Nijalingeshwar Shikshana Mahavidyalaya" to "Aadya Shri. Nijalingeshwar Shikshana Samsthe's Bharat Ratna Dr. S.Radhakrishnan B.Ed. Mahavidyala."
- 3. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students** for **one basic unit** from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 08.03.2019. The institution has not submitted reply to the Show Cause Notice.
- 5. **AND WHEREAS,** the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 25.09.2020. The institution has submitted reply on 12.10.2020.
- 6. AND WHEREAS, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 12.10.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted a faculty list comprising 8 faculty but the same is not approved by the affiliating body. Further, the strength of faculty is not enough even for 1 unit of B.Ed. course as per Appendix 4 of NCTE Regulations, 2014.
- 2. The institution did not submit a "Form A" issued by the respective Bank Manager and re-validation of FDRs of Rs. 5 & 7 lakhs.
- 3. The institution submitted documents regarding LUC, NEC etc. which are in Regional Language. The institution has not submitted English notarised version of LUC/NEC etc.
- 4. The building plan submitted by the institution is neither approved nor legible.
- 5. The Institution did not submit an attested/notarized copy of Building Completion Certificate issued by the competent authority.

Hence, the Committee decided to withdraw the recognition granted to Aadya Shri. NijalingeshwarShikshanSamsthe's Bharat Ratna Dr. S.Radhakrishnan B.Ed. Mahavidyala, Ananth Vidya Nagar, P.B. No.16, Sankeshwar-591313, Belgaum District, Karnataka for conducting B.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Aadya Shri. NijalingeshwarShikshanSamsthe's Bharat Ratna Dr. S.Radhakrishnan B.Ed. Mahavidyala, Ananth Vidya Nagar, P.B. No.16, Sankeshwar-591313, Belgaum District, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
