CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Calicut University Centre, DIET Building, Kavaratti, Pin – 682555, Union Territory of Lakshadweep** vide order No. F.LD/B.Ed./SRO/NCTE/2006-2007/6633 dt. 30.06.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 50 students from the academic session 2006-2007.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 24.02.2015 for its willingness of one unit in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 22.07.2019. The institution vide letter dated 22.09.2021 submitted written representation for shifting of Calicut University Centre from Kavaratti to Kadmat.

4. **AND WHEREAS**, the SRC in its 403rd meeting held on 18th – 19th October, 2021 considered the matter and decided to issue letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 10.11.2021. The has submitted reply on 11.01.2022.

5. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution submitted in the name and style of College of Education, Kadmat, Lakshadweep and decided that shifting of premises be permitted to the institution at new address. Further, the Committee also advised the Lakshadweep Administrator to provide infrastructural and instructional facilities on priority basis to ensure quality teacher education is important in this institution. Immediate steps are to be taken to fill the required number of teaching faculty alongwith non-teaching staff under Lakshadweep

Administration. Now onwards the college will have all the academic linkages with Pondicherry Central University only.

The Committee accepted the name of the institution as College of Education, Kadmat, Lakshadweep.

The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic unit of 50 students.”

6. **NOW THEREFORE**, this order is issued permitting the institution namely Calicut University Centre, DIET Building, Kavarattil, Union Territory of Lakshadweep - 682555 for following directions: -

- (i) To Change the name from “**Calicut University Centre**” to “**College of Education**”.
- (ii) To change the location from “**DIET Building, Kavaratti, Pin – 682555, Union Territory of Lakshadweep**” to “**Kadmat, Lakshadweep Union Territory of Lakshadweep.**”
- (iii) Continuation of recognition for **B.Ed. programme** for two-year duration with annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -
 - a. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - b. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - c. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - d. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

8. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land,

building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
