WHEREAS, the recognition was granted to the institution namely Balaji College of Education, Anantapur Revenue Division Near RTC Bus Stand, Neeruganti Street, Anantapur District-515001, Andhra Pradesh run Balaji Educational Society, Anantapur SRC The Pradesh. District-515001. Andhra F.AP/NEW/B.ED./252/SRO/NCTE/2002-2003/6097 dt. 05.03.2003 for conducting (B.Ed.) course of one-year duration from the academic session 2002-03 with an annual intake of 100 students.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 29.01.2015. A revised provisional recognition order was issued to the institution on 12.05.2020 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, The SRC in its 343rd meeting held on 1-2 August 2017 and the Committee decided as under: -
 - These are RPRO cases. In view of the latest instructions, no inspection is required
 - But, these also involve 'shifting'. Therefore, VT Inspection will be required.
 - The SRO's request is noted and permission is given for organizing VT Inspection in
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 21.02.2019.
- AND WHEREAS, the institution has submitted the reply dated 25.09.2020 in response to the Show Cause notice. They had applied for 2 units, and, even RPRO was 2 units.
- AND WHEREAS, the SRC in its 392nd meeting held on December 15th & 16th, 2020 and the Committee decided to issue a Final Show Cause Notice was issued to the institution on 18.12.2020. The institution submitted its reply to the Final Show Cause Notice on 08.01.2021.
- AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 08.01.2019 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has not submitted a certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarized copy of English version of land documents)
- 2. The institution has not submitted Notarized copy of Building Completion Certificate.
 - (i) Date of inspection not mentioned in Building Completion Certificate.
- 3. The Principal does not have NET/Ph.D. as per NCTE Recognition.
 - (i) The institution has not appointed the faculty of Performing Arts.

Hence, the Committee decided to withdraw the recognition granted to Balaji College of Education, Anantapur Revenue Division Near RTC Bus Stand, Neeruganti Street, Anantapur District-515001, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Balaji College of Education, Anantapur Revenue Division Near RTC Bus Stand, Neeruganti Street, Anantapur District-515001, Andhra Pradesh run by Balaji Educational Society, Anantapur District-515001, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. academic session 2020-2021 onwards.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
