ORDER

WHEREAS, the recognition was granted to the institution namely St. Joseph's College of Education for Women, Gunter District-522001, Andhra Pradesh vide SRC (NCTE) order no. F./SRO/NCTE/97-98/5074 dated 09.02.1998 for conducting B.Ed. course of one-year duration with an annual intake of 200 students.

- AND WHEREAS, on promulgation of NCTE Regulations 2014, the institution is submitted affidavit has not submitted for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016, decided as 3. under:

"For cases of B.Ed. (2 Units) in the existing institution, where RPRO, has been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f. 2016-17 to enable them to make admission in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of Waiting for that action to be completed for placing them before the SRC, to save time, VT Inspections can straightaway be ordered. VT Inspection Report can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The institution concerned may be alerted about such action so that they will be prepared to receive the Visiting Teams. They may also be advised to keep in readiness latest approved Faculty Lists for Submission to the VTs."

- AND WHEREAS, as per the decision of SRC Inspection intimation was sent to the institution on 14.06.2016 for VT.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue First SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a First Show Cause Notice was issued to the institution on 06.12.2019.

- 6. AND WHEREAS, the institution has submitted the reply vide dated 20.12.2019 in response to the First Show Cause notice.
- 7. AND WHEREAS, the SRC in its 394th meeting held on 27th 28th January, 2021 considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution St. Joseph's College of Education for Women, Gunter District-522001, Andhra Pradesh for the following courses:-

- (i) B.Ed 2 units (50 students each unit).
- (ii) M.Ed- 1 unit of 50 students.
- 8. NOW THEREFORE, this order is issued permitting the institution i.e. St. Joseph's College of Education for Women, Gunter District-522001, Andhra Pradesh run by Society of Jesus, Mary and Joseph, Gunter District-522001, Andhra Pradesh for continuation of recognition for B.Ed. course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of

the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and aboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

a. Sanctioned programme(s) along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Stadents admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- J. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GiS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
