WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Yerra Krishnamurthy College of Education, Maripivalasa – 534446, Vizianagaram District, Andhra Pradesh run Yerra Krishnamurthy Educational Society, Church Street, Parvatipuram-535501, Andhra Pradesh vide SRC order F.AP/B.Ed./New/43/SRO/NCTE/2000-2001/1162 dt. 14.07.2000 for conducting (B.Ed.) course of one-year duration from the academic session 2000-2001 with an annual intake of 100 students.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 12.01.2015. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. AND WHEREAS, SRC in its 314th meeting held on 27th to 28th May 2016, decided to issue inspection intimation letter. As per the decision of SRC Inspection intimation was sent to the institution on 14.06.2016. The institution submitted its written representation on 17.10.2016.

4. AND WHEREAS, SRC in its 345th meeting held on 21st & 22nd September 2017 decided to issue a letter. As per the decision of SRC a letter was sent to the institution on 06.10.2017 reduced 2 units to 1 unit.

5. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on 03.05.2019.

6. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 10.12.2019. The institution submitted its reply to the FSCN vide letter dated 30.12.2019.

7. AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents

furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 30.12.2019 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. *The institution has submitted photocopy of Land Document.*
 - (i) *The institution has not submitted certified copy of land documents.*
2. *The institution has submitted photocopy of Building & Site plan which is not readable.*
3. *Date inspection not mentioned in Building Completion Certificate.*
4. *The institution has not submitted a Letter regarding approval of faculty issued by the affiliating body submitted.*
5. *The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.*

Hence, the Committee decided to **withdraw the recognition** granted to **Yerra Krishnamurthy College of Education, Maripivalasa – 534446, Vizianagaram District, Andhra Pradesh** for conducting **B.Ed** course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Yerra Krishnamurthy College of Education, Maripivalasa – 534446, Vizianagaram District, Andhra Pradesh** run by **Yerra Krishnamurthy Educational Society, Church Street, Parvatipuram-535501, Andhra Pradesh** for conducting **B.Ed. course** of two years duration with an annual intake of **100** students (2 units) w.e.f. academic session 2020-2021 onwards.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
