WHEREAS, the Recognition was granted to the institution namely Christian College of Education, II-250/E/4/3A, Reddy's Colony, Mananpalle, Chittoor District-517325, Andhra Pradesh run by Gods Foundation Nursing Educational Society, Kurnool District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APSO6304/B.Ed/2006-2007/675 dt. 12.04.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the Southern Regional Committee in its 250th meeting held on 11th 13th August 2013, considered the above matter and decided to ask the institution to submit all land and building documents and approved staff list for causing inspection of new premises. As per the decision of SRC, a letter was sent to the institution on 30.09.2013. The institution submitted a written representation on 23.06.2014 along with documents.
- 3. AND WHEREAS, the Southern Regional Committee in its 269th meeting held during 1st-2nd July, 2014, considered the above matter and decided to ask the institution to submit all land and building documents and approved staff list for causing inspection of new premises. In the meanwhile, on 09.07.2014, the Correspondent of institution submitted a letter.
- 4. AND WHEREAS, the SRC in its 276th Meeting held during 07-09 January, 2015 considered the matter, written representation of the institution for shifting dated 23.06.2014, reply of the Institution dated 26.12.2015 along with affidavit expressing their willingness to process their application as per Regulations 2014, decided and advised Southern Regional Office to Cause Inspection of the said institution. As per the decision of SRC, an inspection letter issued to the institution on 28.01.2015. The inspection of the institution was conducted on 01.02.2015 and the VT Report was received by this office on 05.02.2015.
- **5. AND WHEREAS,** the SRC in its 280th meeting held during 12th 14th February, 2015 considered the matter, VT report dated 01.02.2015, VCD of the institution, and all relevant documentary evidence and decided to serve Show cause Notice under NCTE Act. for the following deficiencies:
 - The institution to submit duly approved staff list.
- 6. AND WHEREAS, as per the decision of SRC, a Show Cause Notice was issued to the institution on 27.02.2015. The institution submitted a written representation on 07.04.2015.

- 7. AND WHEREAS, the SRC in its 285th meeting held on 17th April, 2015 considered the matter and decided as under:
 - 1. Permit shifting,
 - 2. Ask them to ensure full adherence to the new norms & standards before 30.10.2015.

Accordingly, the Revised Provisional Recognition order was issued to the institution at its owned permanent building i.e. Christian College of Education, 1-331-2, Sivalayam Street, Opp. Arogyamatha High School, Madanapalle, Chittoor District-517325, Andhra Pradesh for conducting B.Ed. programme with an annual intake of 100 students of 2 basic units (50 students each unit) on 14.05.2015.

- **8. AND WHEREAS,** Demand Draft for revailedation was sent to the institution on 25.06.2015. The institution submitted Revalidated Demand Draft on 06.07.2015. The institution submitted a letter regarding Return on Original Documents on 02.03.2016. A letter was sent to the institution on 16.03.2016 along with Original Documents.
 - 1. Land documents dated 20.01.2014 and 11.05.2012.
 - 2. Encumbrance Certificate dated 11.05,2012 and 02.06.2014.
 - 3. Building Plan.
 - 4. Building Completion Certificate dated 28.04.2014.
 - 5. Land Usage Certificate dated 24.04.2014.
 - 6. Fixed Deposit Receipts.

The institution submitted documents as per revised recognition order on 02.05.2016.

9. AND WHEREAS, the SRC in its 314th meeting held on 27th – 28th May, 2016, decided as under:

"For cases of B.Ed (2 Units) in the existing institution, where RPRO, has been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f. 2016-17 to enable them to make admission in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of Waiting for that action to be completed for placing them before the SRC, to save time, VT Inspections can straightaway be ordered. VT Inspection Report can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The institution concerned may be alerted about such action so that they will be prepared to receive the Visiting Teams. They may also be advised to keep in readiness latest approved Faculty Lists for Submission to the VTs."

As per the decision of SRC, Inspection intimation was sent to the institution on 14.06.2016.

- 10. AND WHEREAS, the SRC in its meeting held on 22nd Oct, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue First SCN. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 24.10.2019. The institution vide letter dated 15.11.2019 submitted reply to the First Show Cause Notice.
- 11. AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February 2020 has considered the matter and the Committee decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 26.02.2020. The institution vide letter dated 09.07.2020 submitted reply to the Final Show Cause Notice.
- 12. AND WHEREAS, the matter was further considered by the SRC in its 394th meeting held on January 27-28, 2021 and the Committee decided as follows: -


The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 09.07.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- a. Lease deed for a period of 3 years commencing from 26.08.2006 and the concluding on 25.08.2009. (Rented)
- b. The institution has submitted a Building Plan in which Multi-purpose hall area is not mentioned.
- c. A Letter regarding approval of faculty issued by the affiliating body has not submitted.

Hence, the Committee decided to withdraw the recognition granted to Christian College of Education, II-250/E/4/3A, Reddy's Colony, Mananpalle, Chittoor District-517325, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 13. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted Christian College of Education, 1-331-2, Sivalayam Street, Opp. Arogyamatha High School, Madanapalle, Chittoor District-517325, Andhra Pradesh run by Gods Foundation Nursing Educational Society, Kurnool District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. academic session 2020-2021 onwards.
- 14. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -



or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

15. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
