WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **St. Francis Institute of Elementary Education, No.253, Gandhinagar, Janagaon Road Village, Suryapet Post & Taluk, Nalgonda District-508213, Andhra Pradesh** run by **St. Francis Educational Society, No. B-1, M.S. Apartments CPL Road, Amberpet Village & Post, Hyderabad Taluk, Hyderabad District, Andhra Pradesh** vide SRC (NCTE) order No. No.F.SRCAPP793/D.El.Ed./AP/2012/46634 dated 09.10.2012 for conducting **D.El.Ed course** of two-year duration with an annual intake of **50 students** from the academic session 2012-2013.

AND WHEREAS, The institution vide letter dated 17.12.2019 submitted written representation for closing of the institution The SRC in its 394<sup>th</sup> meeting held during 27<sup>th</sup> - 28<sup>th</sup> January, 2021 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management by its letter dt 17.12.2019 by withdrawing the recognition granted to **St. Francis Institute of Elementary Education, No.253, Gandhinagar, Janagaon Road Village, Suryapet Post & Taluk, Nalgonda District-508213, Telangana** for conducting **D.El.Ed course** under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- NOC from the affiliating body.
- NOC from the staff/faculty.
- Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of namely **St. Francis Institute of Elementary Education, No.253, Gandhinagar, Janagaon Road Village, Suryapet Post & Taluk, Nalgonda District-508213, Andhra Pradesh** run by **St. Francis Educational Society, No. B-1, M.S. Apartments CPL Road, Amberpet Village & Post, Hyderabad Taluk, Hyderabad District, Andhra Pradesh** for conducting **D.El.Ed programme** of two years duration with an annual intake of 50 students (1 unit) w.e.f. academic session 2020-2021.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
