WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Carmel Teacher Training Institute, Plot/Khasara No. 55/4B, 58/1B, Chodimella Village, Eluru Post & Taluk, West Godavari District-534002, Andhra Pradesh** run **Carmel Ministries, Plot No. 24C-4-22, Pathabad Road, Eluru Village, Pathabad Post, Eluru Taluk, West Godavari District-534002, Andhra Pradesh**. The SRC vide order SRCAPP946/D.El.Ed/AP/2013-14/55853 dt. 03.01.2014 for conducting (D.El.Ed.) course of two-year duration from the academic session 2014-15 with an annual intake of 50 students.

2. **AND WHEREAS**, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.

3. **AND WHEREAS**, the matter was considered by SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup>-24<sup>th</sup> July, 2020 and decided to issue Show Cause Notice. As per the decision of SRC, a Show Cause Notice was issued to the institution on 29.9.2020. The institution did not submit any reply of Show Cause Notice till date.

4. **AND WHEREAS**, the matter was further considered by the SRC in its 394<sup>th</sup> meeting held on January 27-28, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The Committee noted that the institution has not submitted any reply in response to the Show Cause Notice issued to the institution on 29.09.2020.
2. Further, the Committee also perused the letter received from the Director, School Education, Govt. of Andhra Pradesh with a request to withdraw the recognition to this institution as they committed irregularities in the process of admission.

Hence, the Committee decided to **withdraw the recognition** granted to **Carmel Teacher Training Institute, Plot/Khasara No. 55/4B, 58/1B, Chodimella Village, Eluru Post & Taluk, West Godavari District-534002, Andhra Pradesh** for



conducting D.El.Ed course w.e.f. the 2020-2021 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

5. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Carmel Teacher Training Institute, Plot/Khasara No. 55/4B, 58/1B, Chodimella Village, Eluru Post & Taluk, West Godavari District-534002, Andhra Pradesh** run by **Carmel Ministries, Plot No. 24C-4-22, Pathabad Road, Eluru Village, Pathabad Post, Eluru Taluk, West Godavari District-534002, Andhra Pradesh** for conducting D.El.Ed. course of two years duration with an annual intake of 50 students w.e.f. academic session 2020-2021 onwards.

6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
