WHEREAS, the recognition was granted to the institution namely Sri Krishna D.Ed. College, P.No.25, Housing BO. Street Perkit Village, Post, Armoor Taluka, Medak District, Andhra Pradesh run by Ratana Educational Society, P.No.12-3-107/2, Nesar Poora Road, Siddipet Village, Siddipet Twon, Medak District-502103 Andhra Pradesh vide SRC (NCTE) order No. F.SRCAPP1357/D.El.Ed/AP/2012/45851 dated 14.09.2012 for conducting D.El.Ed course of two-year duration with an annual intake of 50 students from the academic session 2012-2013.

AND WHEREAS, The institution submitted vide email dated 09.01.2020 a letter submission of closing Institution The SRC in its 394th meeting held during 27th – 28th January, 2021 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the management by its letter dt 09.01.2020 by withdrawing the recognition granted to **Sri Krishna D.Ed. College, P.No.25, Housing BO. Street Perkit Village, Post, Armoor Taluka, Medak District, Andhra Pradesh** for conducting **D.El.Ed course** under clause 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of namely Sri Krishna D.Ed. College, P.No.25, Housing BO. Street Perkit Village, Post, Armoor Taluka, Medak District, Andhra Pradesh run by Ratana Educational Society, P.No.12-3-107/2, Nesar Poora Road, Siddipet Village, Siddipet Twon, Medak District-502103 Andhra Pradesh for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 unit) w.e.f. academic session 2020-2021.

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
