**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely Shushruti B.Ed. College, No. 68, Shushrutinagar, Peenya II Stage, Bangalore, Karnataka-560091 run by Shushruti Education Trust, No. 68, Shushrutinagar, Peenya II Stage, Bangalore, Karnataka-560091 vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/4794 dt. 02.12.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

**AND WHEREAS**, the institution has submitted revised order reply on 31.10.2015 & 29.02.2016. The SRC in its 314<sup>th</sup> meeting held during 27<sup>th</sup> & 28<sup>th</sup> May 2016 considered the reply of the revised order and decided to conduct inspection. As per the decision of SRC, a letter was issued to the institution on 14.06.2016. Thereafter, the institution has submitted a letter dt. 17.02.2017 seeking permission for changing of the management from the "Shushruti Education Trust (R) to Shushruti Academy of Higher Education Trust (R).

**AND WHEREAS**, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22<sup>nd</sup> Oct, 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue First SCN. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on dt. 24.10.2019. The institution vide letter dt. 25.11.2019 submitted reply to the First Show Cause Notice on dt. 24.10.2019.

**AND WHEREAS**, the SRC in its 389<sup>th</sup> Meeting held on 12<sup>th</sup> & 14<sup>th</sup> October 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per directed a Final Show Cause Notice was issued to the institution on dt. 16.10.2020. The institution submitted its reply along with documents on dt. 18.11.2020.

**AND WHEREAS**, the SRC in its 394<sup>th</sup> meeting held on 27<sup>th</sup>-28<sup>th</sup> January 2021 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee considered the reply submitted by the institution on 18.11.2020 in respect to the Final Show Cause Notice and found the following deficiencies:*

1. The building plan submitted by the institution is not approved by the Competent authority.
2. The institution did not submit Building Completion Certificate.
3. The institution did not submit Non-Encumbrance Certificate.
4. The institution has submitted xerox copy of FDRs all were matured.
5. The institution has submitted Form 'A' which is not signed by the respect Bank.
6. The institute did not submit original copy of FDRs.
7. The institute had submitted proforma signed by the affiliating body regarding approval of faculty but only in respect of 15 instead of 16.

8. The institution has not submitted Affidavit clearly stating status about land & Building and Management (Society/Trust) at the time of recognition and its present status giving following details:

- (i) Details of land & Building available at the time of recognition with the institution.
- (ii) Details of land & Building now available with the institution.

Hence, the Committee decided to **withdraw the recognition** granted to **Shushruti B.Ed. College, No. 68, Shushrutinagar, Peenya II Stage, Bangalore, Karnataka-560091** for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

**NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Shushruti B.Ed. College, No. 68, Shushrutinagar, Peenya II Stage, Bangalore, Karnataka-560091** run by **Shushruti Education Trust, No. 68, Shushrutinagar, Peenya II Stage, Bangalore, Karnataka-560091** for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
