WHEREAS, the institution S.R.S. College of Education, N.H. – 13, Pillekeranahalli Extension, Chitradurga-577502, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2005-2006/4817 dt. 21.12.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 19.01.2015, the provisional revised recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016 decided to conduct inspection of the institution. Accordingly, inspection letter was sent to the institution on 13.06.2016. The inspection was conducted on 11 & 12 November 2016.

AND WHEREAS, the SRC in 381st meeting held on 31st Oct & 1st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, First Show Cause was issued on 08.11.2019. The institution vide letter dated 07.12.2019 submitted its reply to the First Show Cause Notice.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, Final Show Cause Notice was issued on 26.10.2020. The institution vide letter dated 20.01.2021 submitted its reply to the Final Show Cause Notice.

AND WHEREAS, the matter was considered by the SRC in its 394th Meeting held on 27th-28th January 2021as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution S.R.S. College of Education, N.H. – 13, Pillekeranahalli Extension, Chitradurga-577502, Karnataka for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., S.R.S. College of Education, Survey No. – 57/A, N.H. – 13, Pillekeranahalli Extension, Chitradurga-577502, Karnataka for B.Ed. course run by Sri Ranganthaswamy Education Society,

The institution shall ensure that the required number of academic staff duly IV. approved by affiliating body for conducting the course should always remain in

position.

The institution shall ensure that the required number of academic staff duly ٧. approved by affiliating body for conducting the course should always remain in

position.

Further, the institution is required to fulfil all such other requirements as may be 8. prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self - Appraisal Report at the 9. end of each academic year along with the statement of annual accounts duly audited by

a Chartered Accountant.
