WHEREAS, the institution Sharda College of Education, Muthyalpet, Mulbagal Town 563131, Kolar District, Karnataka was granted recognition for conducting B.Ed course of one year duration with an annual intake of 100 students vide SRC, NCTE order dt 08.02.2005.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 14.01.2015, the provisional revised recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 50 students from the academic session 2015-16.

AND WHEREAS, the matter was placed before the SRC in its 369th meeting wherein the Committee considered the matter and decided to issue Show Cause Notice to submit the representation on in respect to the RPRO. Accordingly, a Show Cause Notice (SCN) dated 25.04.2019 was issued to the institution. The institution has submitted its reply on 19.01.2021.

AND WHEREAS, the matter was considered by the SRC in its 394th Meeting held on 27th-28th January 2021as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sharda College of Education, Muthyalpet, Mulbagal Town 563131, Kolar District, Karnataka for B. Ed programme for 1 basic unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e., Sharda College of Education, Survey No.- 586, Muthyalpet, Mulbagal Town 563131, Kolar District, Karnataka for B.Ed. course run by Sri Sharda Vidya Peeta Trust, Muthyalpet, Mulbagal 563131, Kolar District, Karnataka for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- The institution shall comply with the various other norms and standards prescribed II. in the NCTE Regulations, 2014 as amended from time to time.
