WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely TDTA D.S Daniel Rajammal College of Education for Women, Ilanji, Tenkasi Taluk, Tirunelveli-627805, TamilNadu vide order No. F.SRO/NCTE/2007-2008/14106 dated 05.11.2007 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution was submitted affidavit dated 13.01.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388^{th} meeting held on $14^{th}-15^{th}$ September has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 11.11.2021. The institution vide letter dated 23.11.2021 submitted reply of the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 the matter was considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 29.12.2021. The management of the institution has submitted its reply on 19.01.2022 & 02.02.2022.
- 5. **AND WHEREAS**, the SRC in its 407th Meeting held on 15th February 2022 considered the matter and Committee decided to withdraw the Recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APS01823/B.Ed /TN/2022/130524 dated 28.02.2022 was issued to the institution.
- 6. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No. 13290/2022 & CM APPLs 40295/2022, 40296/2022 titled as TDTA D.S. Daniel Rajammal College of Education for Woman Versus National Council for Teacher Education & Anr.
- 7. **AND WHEREAS**, the SRC in its 414th meeting held on 26th 27th September 2022 has considered the matter and decided to participate in the counselling for the academic session 2022-2023. However the withdrawal order issued earlier will be effective from the academic

year 2023-2024. Accordingly, as per the decision of SRC, a letter was issued to the institution on 12.10.2022.

- **8. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-122/E-252807/2022 Appeal/7th Meeting, 2022 Appeal No.APPLSRC202214355 dated 19.10.2022 appeal remand back the order appealed against. The management of the institution did not submit any reply to the Appeal Remand Back.
- **9. AND WHEREAS,** the SRC 415th meeting held on 3rd & 4th November 2022 considered the matter and committee decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 17.11.2022. The institution has submitted reply of FSCN vide letter dated 05.12.2022.
- **10. AND WHEREAS,** the SRC in its 419th meeting held on 13th January 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution TDTA D.S Daniel Rajammal College of Education for Women, Survey No. 427/2, 448 449, D. No. 50, 50/1, 51, 51/1, 52, 52/1, Ilanji, Ilanji Village & Panchayat, Tenkasi Taluk, Tirunelveli-627805, TamilNadu for B.Ed. programme for 2 basic units of 50 students each".

- 11. NOW THEREFORE, this order is issued permitting the institution i.e. TDTA D.S Daniel Rajammal College of Education for Women, Survey No. 427/2, 448 449, D. No. 50, 50/1, 51, 51/1, 52, 52/1, Ilanji, Ilanji Village & Panchayat, Tenkasi Taluk, Tirunelveli-627805, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- **12.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **13.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - i. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **15.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
