CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Alva's College of Physical Education, Sundari Ananda Alva Campus, Vidyagiri, Moodbidri, Dakshina Kannada District, Karnataka-574227** run by **Alva's Education Foundation, Moodbidri, Karnataka** vide SRC order No. F.SRO/NCTE/B.P.Ed./2005-2006/509 on 20.04.2005 for conducting B.P.Ed. course of one-year duration from the academic session 2005-2006 with an annual intake of 50 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 19.01.2015 for its willingness in B.P.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 20.05.2015 for conducting **B.P.Ed. course of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16.**

3. **AND WHEREAS**, the institution has submitted a request letter on 03.06.2015. A Corrigendum was issued vide order no. F.SRO/NCTE/APSO1946/B.P.Ed./KA/2015-2016/67237 dt. 16.06.2015 for notified instead of words '**Alva's College of Education, Sundari Ananda Alva Campus, Vidyagiri, Moodbidri, Dakshina Kannada District, Karnataka-574227**' may be read as '**Alva's College of Physical Education, Sundari Ananda Alva Campus, Vidyagiri, Moodbidri, Dakshina Kannada District, Karnataka-574227.**

4. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 & 375th Meeting held on 13th & 14th May, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents / VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 16.05.2019. The institution has submitted its reply dt. 05.06.2019.

5. **AND WHEREAS**, the SRC in its 379th Meeting held on 21st & 22nd August, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 28.08.2019. The institution has submitted its reply on 18.09.2019 & 13.01.2020.

6. **AND WHEREAS**, the institution in its 413th Meeting held on 22nd & 23rd August, 2022 the matter was considered and decided to issue Show Cause Notice to the institutions who filled the PAR with certain deficiencies. In view of the above decision, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 14.09.2022. The institution has submitted its reply on 24.09.2022.

7. **AND WHEREAS**, the SRC in its 417th Meeting held on 01st & 02nd December, 2022 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 14.12.2022. The institution has submitted its reply on 09.01.2023.

8. **AND WHEREAS**, the SRC in its 419th Meeting held on 13th January, 2023 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Alva's College of Physical Education, Survey No. 341, 219, 292, Ward No. 5, Vidyagiri, Puthige Village, Moodbidri, Dakshina Kannada, Karnataka-574227 for B.P.Ed. programme for 1 basic unit of 100 students."


9. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Alva's College of Physical Education, Survey No. 341, 219, 292, Ward No. 5, Vidyagiri, Puthige Village, Moodbidri, Dakshina Kannada, Karnataka-574227** run by **Alva's Education Foundation, Survey No. 341, 219, 292, Ward No. 5, Vidyagiri, Puthige Village, Moodbidri, Dakshina Kannada, Karnataka-574227** for Continuation of recognition for **B.P.Ed. programme** for two years duration with an annual intake of **1 basic unit of 100 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as

laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
