WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Mar Ivanios College of Education, Kunthoor Perabe, Puttur, Dakshina Kannada District, Karnataka - 574285 run by Maria Social Service, Shimoga, Karnataka vide order no. F.SRC/NCTE/B.Ed./2004-2005/9038 dt. 02.12.2004 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 23.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- AND WHEREAS, the institution has submitted a request letter on 27.06.2015 for grant of recognition one basic unit of 50 students. Accordingly, as per the request a corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS02434/B.Ed./KA/2015/69386 dt. 06.07.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) form the academic session 2015-16 instead of two units.
- 4. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 has considered the matter and decided to issue Show Cause Notice to all such institution which have not submitted compliance of RPRO. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 24.04.2019. The institution has not submitted reply of Show Cause Notice.
- 5. AND WHEREAS, the Sub-Committee constituted by the SRC in its 380th Meeting held on 22nd Oct, 2019. The Sub-Committee decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 09.10.2019. The institution has submitted reply of Final Show Cause Notice dt. 30.10.2019.
- AND WHEREAS, the SRC in its 384th Meeting held on 12th & 13th February, 2020 has 6. considered the matter and decided to issue Last Reminder (letter) to the institution. Accordingly, as per the decision of SRC Last Reminder (letter) was issued to the institution on 26.02.2020. The institution has submitted a written representation on 26.02.2020 through email.
- 7. AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC withdrawal order vide no. F.SRO/NCTE/APSO2434/B.Ed./KA/2021/129747 dt. 30.12.2021 was issued to the institution.
- AND WHEREAS, in compliance of order dt. 31.10.2022 the RD, SRC has already passed order dt. 25.11.2022 no. SRO/NCTE/APSO2434/B.Ed./KA/2022/137594-137596 for confirmation.

- 9. AND WHEREAS, the SRC in its 417th Meeting held on 01st & 02nd December, 2022 has considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC a letter was issued to the institution on 12.12.2022.
- 10. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-193/E-261178/2022 Appeal/9th Meeting, 2022 APPLSRC202214293 dt. 30.11.2022 appeal remand back the order appealed against. The institution has submitted reply of appeal remand back on 12.12.2022.
- 11. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Mar Ivanios College of Education, Survey No. 171-1A1B, Perabe Village Panchayat, Kunthoor Perabe, Puttur, Dakshina Kannada District, Karnataka-574285 for B.Ed. programme, 1 basic unit of 50 students."

- 12. NOW THEREFORE, this order is issued permitting the institution i.e., Mar Ivanios College of Education, Survey No. 171-1A1B, Perabe Village Panchayat, Kunthoor Perabe, Puttur, Dakshina Kannada District, Karnataka-574285 run by Maria Social Service Society, Survey No. 171-1A1B, Perabe Village Panchayat, Kunthoor Perabe, Puttur, Dakshina Kannada District, Karnataka-574285 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 14. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
