WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Don Bosco College of Education, Chittapur Road, Yadgir, Gulbarga District, Karnataka-585202 run by The Bangalore Salesian Society, Bangalore, Karnataka vide order no. F.SRO/NCTE/B.Ed./2005-2006/4835 dt. 21.12.2005 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 19.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 371st meeting held on 25th & 26th February, 2019 has considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 06.03.2019. The institution did not submit any reply to Show Cause Notice.
- 4. AND WHEREAS, the matter was considered before the Committee on 388th Meeting held on 14th & 15th September 2020 and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 12.10.2020. The institution did not submit any reply to Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 405th meeting held on 13th & 14th December, 2021 considered the matter and decided to Withdraw recognition order. Accordingly, as per decision of SRC Withdrawal order no. F.SRO/NCTE/APS03075/B.Ed./{KA}/2021/129711 dated 30.12.2021 for B.Ed. course was issued to the institution.
- **6. AND WHEREAS,** the institution has submitted a written representation attached with documents on 04.03.2022.
- 7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-21/E-236373/2021 Appeal/5th Meeting, 2022 APPLSRC202114246 dt. 12.07.2022 appeal remand back the order appealed against. The institution has submitted appeal remand back reply on 27.07.2022.
- 8. AND WHEREAS, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 05.09.2022. The institution has submitted its reply on 20.09.2022.

9. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Don Bosco College of Education, Survey No. 584, Chittapur Road, Yadgir, Gulbarga District, Karnataka-585202 for B.Ed. programme 1 basic unit of 50 students."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e., Don Bosco College of Education, Survey No. 584, Chittapur Road, Yadgir, Gulbarga District, Karnataka-585202 run by The Bangalore Salesian Society, Survey No. 584, Chittapur Road, Yadgir, Gulbarga District, Karnataka-585202 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- i. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
