CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Karnataka College of Education, No. 33/2, Tirumenahalli Village, Hegde Nagar Main Road, Jakkur Post, Yelhanka Hobli, Bangalore North, Karnataka-560064** run by **Karnataka Education Trust, Bangalore, Karnataka** vide order no. F./SRO/NCTE/B.Ed./2004-2005/8825 dt. 30.11.2004 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, the SRC has considered the matter in its 193rd meeting held on 21-22 June 2010 and decided to withdraw the recognition to the B.Ed. course. Accordingly, a withdrawal order was issued to the institution on 04.08.2010 vide order no. F.SRO/NCTE/2010-2011/20224.

3. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89—1082/2010 Appeal dated 11.03.2011 considered the matter and reversed the order of SRC with the direction to issue a show cause notice to the institution and take necessary action.

4. **AND WHEREAS**, a Show Cause Notice was issued to the institution on 09.05.2011 for B.Ed. Programme. The institution not submitted to the Show Cause Notice.

5. **AND WHEREAS**, the SRC has considered the matter in its 376th meeting held on 11th - 12th June 2019 and decided to withdraw the recognition to the B.Ed. course. Accordingly, a withdrawal order was issued to the institution on 02.07.2019 vide order no. F.SRO/NCTE/APSO1797/B.Ed./KA/2019/106351-6359.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-123/E-252945/2022 Appeal/7th Meeting, 2022, APPLSRC202214353 dated 19.10.2022 considered the matter decided as under:-

'After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded appeal deserved to be rejected and therefore, the impugned withdrawal order issued by SRC is confirmed.'

7. **AND WHEREAS**, the institution filed Writ Petition before Hon'ble High Court of Karnataka at Bengaluru bearing W.P No. 22712/2022 titled as Karnataka College of Education B.Ed. Versus National Council for Teacher Education and another whereby the Hon'ble High Court has directed that:-

- (i) *Writ petition is allowed*
- (ii) *Order dated 02nd July, 2019 (Annexure-A) passed by the respondent No. 1 and order dated 19th October, 2022 (Annexure-B) passed by the respondent No.2 are quashed.*

- (iii) *The matter is remitted back to the respondent No. 1 to reconsider the issue afresh and pass appropriate orders in accordance with law, after affording opportunity to the petitioner college.*
- (iv) *Liberty is reserved to the petitioner to submit a reply/ document, if any to put-forth the case on merits.*

8. **AND WHEREAS**, as per direction of Hon'ble High Court order dated 16.12.2022 the institution has submitted documents on 10.01.2023. The SRC in its 419th Meeting held on 13th January, 2023 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Karnataka College of Education, No. 33/2, Tirumenahalli Village, Hegde Nagar Main Road, Jakkur Post, Yelahanka Hobli, Bangalore-560064, Karnataka for B.Ed. programme for 2 basic units of 50 students each."

9. **NOW THEREFORE**, this order is issued permitting the institution i.e., Karnataka College of Education, No. 33/2, Tirumenahalli Village, Hegde Nagar Main Road, Jakkur Post, Yelahanka Hobli, Bangalore-560064, Karnataka run by Karnataka Education Trust, No. 33/2, Tirumenahalli Village, Hegde Nagar Main Road, Jakkur Post, Yelahanka Hobli, Bangalore-560064, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

10. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.



12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
