WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, **Srinivasa College of Education, Srinivasa Campus, Pandeshwar, Mangalore, Karnataka-575001** run by **A. Shama Rao Foundation, Mangalore, Karnataka** vide order no. F.SRO/NCTE/B.Ed./2004-2005/9538 dt. 23.12.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 22.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 08.11.2019. The institution has submitted reply on 30.11.2019.

4. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice to the institution on 03.02.2022. The institution has submitted reply on 23.02.2022.

5. **AND WHEREAS**, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 23.02.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The building plan submitted by the institution is not legible.*
- 2. The institution submitted a proforma of Principal and 15 faculty which is not sufficient as per Appendix 4 of NCTE Regulations, 2014.*
- 3. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.*
- 4. Faculty namely Dr. Vijayalakshmi, Mrs. Mamatha Kumari, Mrs. Akshita S, Mrs. Shridevi. M.S. (total 8 faculty) appointed after 09.06.2017 and not qualified with*

NET, hence not eligible to be appointed as per NCTE Regulations, 2014 (amended vide notification dt. 09.06.2017).

*Hence the recognition granted to **Srinivasa College of Education, Srinivasa campus, Pandeshwar, Mangalore-575001, Karnataka** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., **2022-2023**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e., **2022-2023**."*

6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Srinivasa College of Education, Srinivasa Campus, Pandeshwar, Mangalore, Karnataka-575001** run by **A. Shama Rao Foundation, Mangalore, Karnataka** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** with effect from the academic session i.e., **2022-2023** onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate counselling from the academic session i.e., **2022-2023** and the institution is also not permitted to take any fresh admission of students from the academic session **2022-2023**.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
