CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Amitha B.Ed. College, C.A. No. 2, 3rd Main, West of Chord Road, 2nd Stage, Mahalakshmpuram, Bangalore, Karnataka-560086** run by **Ambedkar Memorial Society, Bangalore, Karnataka** vide order no. F./SRO/NCTE/B.Ed./2004-2005/8636 dt. 25.11.2004 for Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

2. AND WHEREAS, the SRC in its 268th meeting held on 04th – 05th June, 2014 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal no. F.SRO/NCTE/APSO2174/B.Ed./KA/2014-15/58886 dated 07.08.2014 was issued to the institution.

3. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-104/2015 Appeal/8th Meeting-2015/14656 dated 23.09.2015 appeal reverses the orders.

4. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 17.02.2016 for conducting **B.Ed. course of two years duration with an annual intake of 50 Students (one basic unit) from the academic session 2015-16.**

5. AND WHEREAS, the SRC in its 304th Meeting held on 19th & 20th February, 2016 has considered the matter and decided to restoration of the recognition. Accordingly, as per the decision of SRC the recognition accorded to **Amitha B.Ed. College, C.A. No. 2, 3rd main, West of Chord Road, 2nd Stage, Mahalakshmpuram, Bangalore, Karnataka-560086** is hereby restored vide order no. F.No./SRC/NCTE/APSO2174/B.Ed./KA/2016/87325 dt. 13.07.2016.

6. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 27.03.2019. The institution vide letter dated 15.05.2019 submitted its reply to the show cause notice.

7. AND WHEREAS, the matter was considered in 379th meeting of SRC held on 21st and 22nd and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 28.08.2018. The institution has submitted its reply to Final Show Cause Notice on 17.09.2019.

8. AND WHEREAS, the SRC in its 384th meeting held on 12th – 13th February, 2020 has considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/APSO2174/B.Ed./KA/2020/115815-5821 dated 06.03.2020 was issued to the institution.

9. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-254/E-

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official website.

17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.


