WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Navodaya College of Education, No. 6-2-139/5, Navodaya Nagar, Mantralayam road, Raichur, Karnataka-584103 run by Navodaya Education Trust, Raichur-584102, Karnataka vide order no. F./SRO/NCTE/B.Ed./2004-2005/8933 dt. 30.11.2004 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 10.02.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016. The inspection of the institution was conducted on 19.11.2016 & 20.11.2016 and VT report was received on 28.11.2016.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st October & 01st November 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 06.11.2019. The institution vide letter dated 26.11.2019 has submitted reply to the First Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 403^{rd} Meeting held on $18^{th} 19^{th}$ October 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 03.11.2021. The institution vide letter dated 25.11.2021 has submitted a reply in response to the Final Show Cause Notice.
- **6. AND WHEREAS,** the SRC in its 405th Meeting held on 13th& 14thDecember, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC Withdrawal order was issued to the institution vide order no. F.SRO/NCTE/APS02126/B.Ed./{KA}/2021/129841dated 07.01.2022.
- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-73/E-

245265/2022 Appeal/4th Meeting, 2022 APPLSRC202214300 dt. 26.05.2022 considered the matter and confirmed the impugned W.O. issued by the SRC.

8. AND WHEREAS, the SRC in its 412th Meeting held on 05th & 06th July, 2022 considered the matter and decided as under: -

"The Committee noted the order of the Appellate Authority confirming the withdrawal order issued by the SRC, NCTE. Further the office of the Regional Director, SRC is advised to return the FDRs to the institution by following the prescribed rules and close the file and inform the respective affiliating body / University and the State Govt."

9. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Delhi for bearing W.P (C) No. 15203/2022 & CM APPL 46996/2022 titled as Navodaya College of Education Versus National Council for Teacher Education and Anr Whereby the Hon'ble High Court has directed that: -

"Respondents are directed to update the status of Petitioner-Institute, within a period of one week from today, and send an intimation in respect thereof to the affiliation university of Petitioner-Institute as well as to the concerned Department of Education to enable them to participate in counselling and admission process for academic session 2022-23."

- 10. AND WHEREAS, in compliance of order dated 03.11.2022, the Regional Director, SRC has passed an order dated 25.11.2022 vide order no. File No.SRO/NCTE/APSO2126/B.Ed./KA/2022/137588-137590. This is only for confirmation.
- 11. AND WHEREAS, the SRC in its 417th Meeting held on 01st & 02nd December, 2022 has considered the matter and decided to issue a letter to the Registrar, Gulbarga University. Accordingly, as per the decision of SRC a letter was issued to the Gulbarga University dt. 13.12.2022.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-73/E-245265/2022 Appeal/10th Meeting, 2022 APPLSRC202214300 dt. 21.12.2022 considered the matter and remanded back the matter to the SRC with a direction to verify the documents. The institution has submitted reply on 27.12.2022 & 12.01.2023.
- 13. AND WHEREAS, the SRC in its 419th Meeting held on 13th January, 2023 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Navodaya College of Education, Survey No. 1129/2, Navodaya Nagar, Mantralayam Road, Raichur-584103, Karnataka for B.Ed. programme, 2 basic units of 50 students each."

- 14. NOW THEREFORE, this order is issued permitting the institution i.e., Navodaya College of Education, Survey No. 1129/2, Navodaya Nagar, Mantralayam Road, Raichur-584103, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 15. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 16. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.

- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
