CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Shri Bujari & Biradar College of Education, Gulbarga Road, Afzalpur, Gulbarga-585301, Karnataka** run by **Paripoorna Education and Rural Development Society, Sindagi, Gulbarga Road, Afzalpur, Gulbarga District, Karnataka** vide order no. F./SRO/NCTE/B.Ed./2006-2007/8405 dt. 21.08.2007 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 17.02.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 15.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) of 50 students each from the academic session 2015-16.**

3. **AND WHEREAS**, the matter was placed before in 314th meeting of SRC held on 27th & 28th May 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter was issued to the institution on 13.06.2016. The inspection of the institution was conducted on 11.11.2016 and VT report was received on 15.11.2016.

4. **AND WHEREAS**, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided to issue SCN to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 01.09.2022. The institution did not submit any reply to Show Cause Notice.

5. **AND WHEREAS**, the institution has filled the PAR for the academic session 2020-21 in compliance of public notice dt. 29.09.2021 issued by NCTE HQ.

5. **AND WHEREAS**, the SRC in its 413th meeting held on 22nd – 23rd August, 2022 took note about the institution who have filled the PAR with certain deficiencies. In view of the above decision, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 15.09.2022. The institution has submitted reply on 29.09.2022.

6. **AND WHEREAS**, the SRC in its 417th Meeting held on 01st & 02nd December, 2022 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 12.12.2022. The institution has submitted its reply dt. 31.12.2022.

7. **AND WHEREAS**, the SRC in its 419th Meeting held on 13th January, 2023 has considered the matter and decided as follows: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Shri Bujari & Biradar College of Education, Survey No. 369/6, Ward No. 17, Kalaburagi Road, Afzalpur/Patten Panchayat Afzalpur Pin-585301, Kalaburagi District, Karnataka for B.Ed. programme for 2 basic units of 50 students each.**”*

8. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Shri Bujari & Biradar College of Education, Survey No. 369/6, Ward No. 17, Kalaburagi Road, Afzalpur/Patten Panchayat Afzalpur Pin-585301, Kalaburagi District, Karnataka run by Paripoorna Education and Rural Development Society, Gulbarga Road, Afzalpur, Gulbarga District, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-




teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
13. The institution shall make available the list of students admitted on its official website.
14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
