WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely Jenney's College of Education, No. 2/67, Manigandam Road, Ramjee Nagar, Tiruchirapalli-620009, Tamilnadu run by Smt. Rani Adaikalaraj Educational and Charitable Trust, Trichy-620012, Tamilnadu vide order No. F. SRO/NCTE/B.Ed /2006-2007/12111 dated 26.09.2007 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 03.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 21.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its  $388^{th}$  meeting held on  $14^{th}-15^{th}$  September, 2020 Committee decided to issue Show Couse Notice. Accordingly, a Show Cause Notice was issued to the institution on 03.11.2020. The institution has submitted reply vide letter dated 11.11.2020 in response to the Show Cause notice.
- **4. AND WHEREAS,** the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> 15<sup>th</sup> September, 2020 Committee decided to issue Final Show Couse Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 22.01.2021. The institution has submitted reply vide dated 19.11.2020 in response to the Show Cause notice.
- 5. **AND WHEREAS**, the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> February 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS08048/B.Ed./TN /395<sup>th</sup>/2021 was issued to the institution on 10.03.2021.
- **6. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-23/E-26430/2022 Appeal/10<sup>th</sup> Meeting, 2022 Appeal No.APPLSRC202114033 dated 21.12.2022 appeal remand back the order appealed against. The institution has submitted reply of Appeal Remand Back Case vide dated 05.01.2023.

7. AND WHEREAS, the SRC in its 419<sup>th</sup> meeting held on 13<sup>th</sup> January 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Jenney's College of Education, Plot/Khasara No. 53/6B4,52/1A,57/1,52/1C,56/5,56/3E,52/1D,52/1B Ramjeenagar Village, Kallikudi Post, Srirangam Taluk, Tiruchirapalli District-620009, Tamilnadu for B.Ed. programme, 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Jenney's College of Education, Plot/Khasara No. 53/6B4,52/1A,57/1,52/1C,56/5,56/3E,52 /1D,52/1B Ramjeenagar Village, Kallikudi Post, Srirangam Taluk, Tiruchirapalli District-620009, Tamilnadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic unit) of 50 students each subject to fulfilment of the following conditions:-
  - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its Page 2 of 5

locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
