WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, B.G. College of Education, Plot No. 1-6, Kamepalli-Brahmanapalle, Panchayat, Piduguralla Mandal, Guntur District – 522413, Andhra Pradesh vide order no. F.SRO/NCTE/SRCAPP14939/B.Ed/AP/2016-2017/85100 dt. 02.05.2016 for B.Ed. Programme of two years duration with annual intake of 2 units of 50 students each from the academic sessions 2016-2017.

- 2. AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 taken a decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.11.2022. The institution has submitted its reply on 05.12.2022.
- 3. AND WHEREAS, the SRC in its 419th Meeting held on 13th January, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution B.G. College of Education, Survey No. 542/B, Kamepalli-Brahmanapalle, Panchayat, Piduguralla Mandal, Guntur District – 522413, Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., B.G. College of Education, Survey No. 542/B, Kamepalli-Brahmanapalle, Panchayat, Piduguralla Mandal, Guntur District 522413, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to the fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
