WITHDRAWAL ORDER**

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Gopal D.Ed. College, No. 115, 2nd Cross, Gowripet, Kolar, Karnataka-563101** run by **Gopal Educational Trust, Kolar District, Karnataka** vide order no. F.SRO/NCTE/D.Ed./2006-2007/722 dt. 12.04.2007 for conducting Elementary (D.Ed.) course of two years duration with an annual intake of 50 (Fifty) students.

2. **AND WHEREAS**, the Southern Regional Committee (SRC) in its 412th meeting held on 5th& 6th July, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. As per decision of the SRC, a Show Cause Notice was issued to the institution on 06.08.2022, but institution has failed to submit the reply. The Final Show Cause Notice was issued on 12.09.2022. The institution has submitted its reply dt. 06.10.2022.

3. **AND WHEREAS**, the SRC in its 419th Meeting held on 13th January, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 10.10.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

1. The institution has not filled Performance Appraisal Report (PAR).

The Committee further observed that the institution did not submit following documents.

- I. *The institution did not submit notarized copy of English translation copy of Non-Encumbrance Certificate.*
- II. *GIS location mention by the institution is not found.*
- III. *The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.*
- IV. *The institution did not submit Land Use Certificate.*
- V. *The institution did not submit Building Completion Certificate under prescribed format.*
- VI. *The building plan submitted by the institution is neither legible nor approved by the competent authority.*
- VII. *The institution did not submit details Form 'A' issued by the bank regarding maintenance of FDRs towards Endowment and Reserve Funds.*

Hence the recognition granted Gopal D.Ed. College, No. 115, 2nd Cross, Gowripet, Kolar, Karnataka-563101 for D.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No

fresh admissions are permitted now onwards. However, if any student is pursuing D.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to **Gopal D.Ed. College, No. 115, 2nd Cross, Gowripet, Kolar, Karnataka-563101** run by **Gopal Educational Trust, No. 115, 2nd Cross, Gowripet, Kolar, Karnataka-563101** for conducting **D.Ed. programme** of two years duration with an annual intake of 50 (Fifty) students. No fresh admissions are permitted now onwards. However, if any student is pursuing **D.Ed. programme** is allowed to continue till, they complete the course.


5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(5. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -
"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
