WITHDRAWAL ORDER

WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, Senthil College of Education, No.36, Thiyagaraja Street, Pondicherry-605001 run by Senthil Education Society, No.36, Thiyagaraja Street, Pondicherry-605001 vide Order No. F.PN/SEC/SRO/NCTE/2005-06/4345 dated 28.11.2005 for conducting B.Ed. Programme of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution was submitted affidavit dated 05.02.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 13.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students each (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** a Corrigendum No.F.SRO/NCTE/APS02970/B.Ed./PO/2015-16/85648 was issued to the institution on 20.05.2019 with an annual intake of 50 students each (two basic units) from the academic session 2015-16.
- **4. AND WHEREAS,** the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 06.10.2020. The management of the institution vide letter dated 23.10.2020 has submitted a reply to the Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 397th meeting held on 25th 26th March 2021 was considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause was issued to the institution on 07.04.2021. The management of the institution vide letter dated 21.04.2021 was submitted a reply to the Final Show Cause Notice.
- **6. AND WHEREAS,** the SRC in its 419th Meeting of SRC held on 16th December 2022 considered the matter for deficiencies in compliance and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 21.04.2021. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted latest approved faculty list by affiliating University.
- 2. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 3. The institution has not submitted Land Usage Certificate approved by the Competent Authority.
- 4. The institution has not submitted an affidavit clearly stating status about land & building and Management in original.

Hence the recognition granted Senthil College of Education, No.36, Thiyagaraja Street, Pondicherry-605001 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Senthil College of Education, No.36, Thiyagaraja Street, Pondicherry-605001 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
