WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Shivaji Teacher Training Institute, Baad, Karwar, Uttarkannada District, Karnataka-581304 run by Shivaji Education Society, Baad, Karwar District, Karnataka vide order no. F.SRO/NCTE/D.Ed./2006-2007/6502 dt. 13.07.2007 for Elementary (D.Ed.) course of two years duration with an annual intake of 50 (fifty) students.

2. AND WHEREAS, the Southern Regional Committee (SRC) in its 413<sup>th</sup> Meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> August, 2022 discussed the matter about the institutions who failed to submit the PAR as advised by the PAR as advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitted the PAR to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC, a Show Cause Notice was issued to the institution on 24.11.2022.

3. **AND WHEREAS**, the institution has submitted a written representation dt. 08.12.2022 as under: -

"With reference to the above subject and Show Cause Notice referred above I have to state as under:-

- 1. Our Shivaji Teachers Training Institute, Baad, Karwar established in the year 2007-08.
- 2. Due to lack of student's strength in admission the said course has been suspended from the academic year 2013-2014.
- 3. The Reserve Fund and Endowment fund invested jointly by the Society and the SRC has been got released and encashed vide our letter number SES/2021-22/62 dt. 05.07.2021. (Certified copy of the same is enclosed.)
- 4. The DEIT, Kumta inspected the institution on 15.10.2022 and submitted the report of closure of Shivaji Teachers Training Institute (Certified copy of the same is enclosed.)

In these circumstances we feel that when the course was suspended, and the course is not in exist the matter of submitting the Performance Appraisal Report does not arise. Hence, it is earnestly respected your good office to kindly withdraw the Show Cause Notice issued in this regard and close the entire file relating to our Shivaji Teachers Training Institute, Baad, Karwar."

4. **AND WHEREAS**, the SRC in its 419<sup>th</sup> Meeting held on 13<sup>th</sup> January, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

## <u>The Committee noted that the institution has not filled Performance Appraisal Report</u> (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 08.12.2022 by withdrawing the recognition granted to **Shivaji Teacher Training** *Institute, Baad, Karwar, Uttarkannada District, Karantaka-581304* for conducting **D.Ed.** *Programme* under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Shivaji Teacher Training Institute, Baad, Karwar, Uttarkannada District, Karantaka-581304 run by Shivaji Education Society, Baad, Karwar, Uttarkannada District, Karantaka-581304 for conducting Elementary (D.Ed.) course of two years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.

**6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा/")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website
