## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Federal Primary Teacher Training Centre, Door No. 13-1-260/277, Paras Vatika Layout, Yemarus, Raichur – 584102, Karnataka vide order no. F.SRO/NCTE/2007-2008/13833 dt. 31.10.2007 for Elementary (D.Ed.) course of two years duration with an annual intake of 50 students.

2. AND WHEREAS, the Southern Regional Committee (SRC) in its 412<sup>th</sup> meeting held on 5<sup>th</sup>& 6<sup>th</sup>July, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. As per decision of the SRC, a Show Cause Notice was issued to the institution on 06.08.2022. The Final Show Cause Notice was issued on 12.09.2022. Reply of SCN / FSCN not submitted by institution. The institution has submitted reply on 27.09.2022.

3. **AND WHEREAS**, the SRC in its 419<sup>th</sup> Meeting held on 13<sup>th</sup> January, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 27.09.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit latest approval of faculty issued by the affiliating body.
- 2. The institution did not submit Building Completion Certificate under prescribed format.
- 3. The building plan submitted by the institution is neither approved by the competent authority nor legible.
- 4. The institution did not submit the notarized English translation of Encumbrance Certificate.
- 5. The institution is required to submit an attested/notarized copy of Land Use Certificate issued by the Competent Authority.
- 6. The institution has submitted only FDRs of Rs. 5+3 Lakhs which is not sufficient as per NCTE Regulation and which has also been matured on 12.08.2011.
- 7. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
- 8. The GIS location of the institution is not found. Either the institution is functioning in different location or has been shifted from the original location

Hence the recognition granted **Federal Primary Teacher Training Centre, Door No. 13-1-260/277, Paras Vatika Layout, Yemarus, Raichur, Karnataka-584102** for **D.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing **D.Ed. programme** is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to *Federal Primary Teacher Training Centre, Door No. 13-1-260/277, Paras Vatika Layout, Yemarus, Raichur, Karnataka-584102* for conducting **D.Ed. course** of two years duration with an annual intake of **50 students**. No fresh admissions are permitted now onwards. However, if any student is pursuing **D.Ed. programme** is allowed to continue till they complete the course.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार भेर किसी राज्य सरकार
