WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely K.R. College of Physical Education, Plot No.385, Street No. NH-7, Vedasandur Village & Post Office, Vedasandur Taluk & City, Dindigul District-624710, TamilNadu run by Hindi Telugu Chetty Minority Trust for Education Community Development, Plot No.385, Street No. NH-7. Vedasandur Village & Post Office, Vedasandur Taluk & City, Dindigul District-624710, TamilNadu vide order No. F. SRO/NCTE/SRCAPP14537/B.Ed./TN/ 2016-17/85134 dated 02.05.2016 for conducting B.P.Ed. programme of two-years duration with an annual intake of One basic unit 100 students (two section of 50 students each) from the academic session 2016-2017.

- AND WHEREAS, the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. In case no reply or part reply to SCN is received by the SRC office. The RD is authorised to issue Final Show Cause Notice in all such matters. Accordingly, as per the decision of SRC, a Final Show Cause was issued to the institution on 23.09.2020. The management of the institution did not submit any reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 421st meeting held on 10th February 2023 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRC/NCTE/SRCAPP14537/B.P.Ed./TN/2023/141275-141279 was issued to the institution on 21.02.2023.
- AND WHEREAS, aggrieved by the Withdrawal Order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-74/E-300037/2023 Appeal/23rdMeeting, 2021 Appeal No.APPLSRC202314586 dated 22.05.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back on 07.06.2023.
- AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and decided as under:-

"The original files of the institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution K.R. College of Physical Education, NH-7. Survey No. 385, V. Pudhukottai Panchayat, K.R. Nagar, Vedasandur, Dindigul District-624710, TamilNadu for B.P.Ed. programme 1 basic unit of 100 students."

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
